Councilman Frazier also questioned why the Town was hiring an out of County firm with less experience than the current attorney who is local in Wappinger Falls and very familiar with the Town codes and whose retainer fees were less than the attorney on this resolution. Supervisor Tompkins replied that the retainer fees are more but the actual litigation fees will be less. Ms. Tompkins stated that the incumbents were elected into office to make changes and move forward and they are. Councilman McMorris said that he also felt the Mr. Roberts has done a fine job but also feels that it is time for a new attorney. He also said that the appointment is only for one year and an adjustment can be made then if necessary.

PUBLIC COMMENT ON NON AGENDA ITEMS

Councilman Welsh stated that he felt that important items that the Town Board should address this year are updating the code regarding the use of radio controlled drones on Town property and secondly put something in the Town Code regarding solar panels.

<u>Karen Snare</u> mentioned that she was disappointed that there was no discussion regarding the resolution of the library issue on the agenda this meeting and hopes that it will be addressed at the next meeting. She said that it was her understanding that the Mid Hudson Library System had given the Town Board a possibility that needs to be approved.

<u>Lisette Hitsman</u> mentioned that the rent for number 11 Tymor Park Road is \$2,300 and number is \$1,600. Mrs. Hitsman also asked about the salary for Planning and Zoning Board members and was told that they would be paid \$100. per meeting. Mrs. Hitsman was also disappointed in the agenda, the Town Board worked from a more detailed agenda than was available to the public.

<u>Elfriede Tillman</u> stated that she was thankful that there had been only one snow storm that roads had to be plowed. She also questioned who was plowing Clove Road, the Town or the County and she was told that she should discuss this with the Highway Superintendent.

<u>Cynthia Fairchok</u> presented the Board with data regarding library usage by Union Vale residents mentioned that full library service was still not available to Union Vale.

Councilman Kelley mentioned that it would be on the agenda to appoint a Library Committee soon.

Ralph Mondello said that he was not opposed to funding the library and is not opposed to giving them \$72,000 but he cautioned to be careful as it was his understanding that the library system would be asking for a minimum of 2% which could be 100 % the following year. The previous Board was looking a 2% increase over each of the next five years. Also Union Vale Town Constables must live in the Town in order to be appointed as Constable.

<u>Joseph Kelley</u> mentioned that at the January 8, 2015 minutes it was stated that items could be added to the agenda before the meeting is opened to the public with the approval of the Supervisor or three members of the Town Council.

MOTION TO ADJOURN

As there was no further comments Supervisor Tompkins offered a motion to adjourn at 8:45 p.m. The motion was seconded by Councilman Welsh and passed with a unanimous vote.
