## VEHICLE HISTORY



### STOLEN

The Police National Computer contains a list of all vehicles currently listed as Stolen.

### WRITTEN OFF

Insurance companies can declare a vehicle to be a total loss following a theft or serious accident.

### OUTSTANDING FINANCE

An outstanding loan agreement could mean the vehicle is legally owned by someone else.

### INTERESTED PARTIES

Other parties can register an interest in a vehicle, particularly if it has been obtained fraudulently.

### SCRAPPED

It is illegal to sell any vehicle registered as scrapped by the DVLA.

### MILEAGE DISCREPANCIES

Previous recorded mileages could indicate that a vehicle's mileage has been changed illegally.

The DVLA hold records for all vehicles that have been imported into the UK.

### EXPORTED

The DVLA hold records for all vehicles that have been exported out of the country.

### COLOUR CHANGES

Number of colour changes to the vehicle registered by the DVLA.

### PREVIOUS PLATES

If a vehicle has had a legitimate registration plate change it will be registered by the DVLA.

The first registration date with the DVLA.

### BODY TYPE

The shape of the vehicle (i.e. convertible, saloon).

**ESTATE**



### CO<sub>2</sub> EMISSIONS

The levels of CO<sub>2</sub> pollution produced by the vehicle.

**294 g/km**



### PREVIOUS KEEPERS

The number of keepers recorded for the vehicle at the DVLA, prior to the current owner.

### ENGINE NUMBER

Unique reference number etched onto the engine.

### ENGINE POWER

Brake Horse Power – imperial measurement of an engine's power.
