## Lakewood Forest Civic Association Board Meeting Minutes – February 1, 2022

The monthly meeting of the LFCA was called to order at 7:00 pm by president Jodi Cole. Other board members present were: Barbara Ward, Scott Johnson, Lori Estepp, Linda Musthaler, and Mary Blacklock.

#### Minutes

#### **Treasurer Report**

Scott J. submitted the monthly financial report. As of January 31, 2022, we had \$27,725.49 in total funds. There is \$12,438.83 in the checking account. The money market account has a balance of \$9,497.61 and the 12-month CD has a value of \$5,570.60. In comparing our budget to actual expenses to date for the current fiscal year, we have a deficit balance of \$5,318. The Fund has received \$15,150.02 on behalf of LFCA but the money has not yet been dispersed.
