ASSISTANT CHIEF CAMPBELL'S REPORT

Ambulance 92 was out of service for a faulty alternator. The alternator has been replaced and is now back in service.

Chandler Services replaced the rear brakes on Engine 91. The engine is back in service.

The Nederman Exhaust system at Station 3 was out of service due to a faulty exhaust motor. The exhaust motor was approximately \$1000.00. Thank you to Lt. Lenz and Engineer Kobialko who installed the new motor and saved the District \$1600.00.

Station 1 shift personnel will be participating in a joint public safety event on April 18 with the Mokena Police Department and Metra at the Front Street railroad station to educate the public on railroad safety.

A joint mutual aid training will be held with surrounding towns at Frankfort's training tower.

ASSISTANT CHIEF CIRELLI'S REPORT

Lt. Mark Sickles gave an update on various projects throughout the District, including new construction projects, site plans for future development, new occupancies, and significant remodels.

We have remained active and committed to supporting Laraway Dispatch in improving their provided service levels. Any issues that we have experienced have been reported to LCC through their notification procedure.

The Frankfort Fire Protection District has given their intent to withdraw from LCC. They hope to move to a new dispatch center by December 1, 2019.

Chief Stephens and A/C Cirelli met with Village of Mokena Mayor Flesicher, Trustee Budzyn and Police Chief Vaccarro on March 27 to open dialogue regarding our services received from LCC and our expectations. Mayor Fleischer expressed his gratitude in our transparency.

The Homer Glen Public Services and Safety committee meeting for April was cancelled.

We currently have three employees out on reported duty-related injuries.

The Fall Senior Luncheon will be held on Monday, May 13.

The Trustees reviewed the March code enforcement reports and public education surveys.

CHIEF'S REPORT

The FY2019 ambulance billing data was reviewed.

The Illinois Public Risk Fund grant fund of \$14,348.00 was received on February 12. These funds will be used to help purchase the STRYKER Power-Load for Ambulance 94.

WORKERS COMPENSATION INSURANCE RENEWAL
