## General Meeting Minutes

April 14, 2022

Board Attendees: Tony McClure, Cal Roberts, Mike Wyckoff, Dan Charles, Dan Grey, Tom Yost, Dom Tarzia, and Vic Gurinowitsch.

Secretary's Report: Minutes from the March 2022 meeting was read by Mike Wyckoff. Tony McClure clarified statement about AR/AK rifles on pistol ranges. They can be used on the old pistol range but not on the two new ranges. With the correction, minutes were approved.

Treasurer's Report: Cal Roberts reported a savings balance of \$130,566.01 and a checking balance of \$6,993.39. Treasurer's Report was approved.

Membership Report: Mike Wyckoff provided a membership report: 9 Board of Directors, 21 Reduced Rate Members and 285 Social Members for a total of 315 out of the 350 limit. We also have 30 Life Members, 4 Honorary and 7 Jr. for an additional 41 with total of 356.

Mike Wyckoff had 8 application for new members: Ivan Babich, John Filby, David Collier, Fritz Retsch, Mark Steffen, Max Steffen, Thomas Broady and Philip Burdette. All applicants, except for Broady, were present. His application was tabled until the May meeting. Final approval for the other seven was voted on and approved by the membership. New members were welcomed by the President. Dan Charles explained the point system and steps necessary to become a Reduced Rate member.

Dan Grey gave an update on the Youth Archery program. Next session will be April 23<sup>rd</sup> with sessions on the 2<sup>nd</sup> and 4<sup>th</sup> Saturdays of the month. For the fall sessions, new equipment will be purchased to allow younger children to participate.

Dan Charles gave an update on Youth Shooting. Next session is April 16th. Normal dates for Youth Shooting are the 1<sup>st</sup> and 3<sup>rd</sup> Saturdays of the month.

Tony McClure gave an update on Ladies Night. The sessions are averaging 10-13 attendees. The next session is April 19th. He expressed his appreciation for the help the RSOs are giving him and commended the ladies for their willingness to learn. Sessions will extend to either June or July.

Vic Gurinowitsch talked about the Conservation Camp coming up in June. The club will sponsor two attendees for the camp. Attendees must be 13 to 15 years old and have completed the Hunter-Trapper education course.
