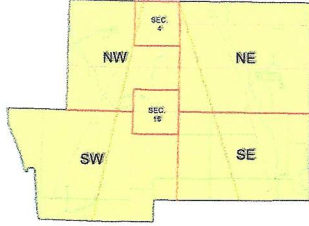

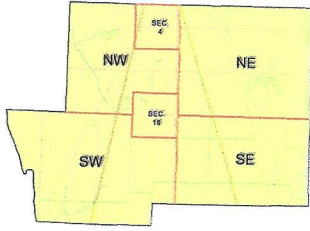

1. The Pleasant Township Zoning Commission met for a Special Public Hearing regarding the Language of the Solar Project on February 11, 2021 @ 7:00 p.m. Board Members of Zoning Commission were present were: Mr. Holler, Mr. Dean, Mr. Dwight and Secretary Miss Barkley. Also in attendance were Trustees Mr. Creasap, Mr. Schrote and Mr. Lust.

2. This was a Public Hearing meeting regarding Solar Panels. Mr. Holler opened the meeting with a moment of silence and Pledge of Allegiance. Mr. Holler read the Language of the Solar Panel Project. The only change was made was 11.26 Purpose -Intent was changed to Solar and Wind Farms from previous Language.
