MARKER UNVEILING WAS A SUCCESS

November 24, 2006 was a beautiful fall day in Greensboro. Members of the Dezell family arrived and were greeted by several members of the Society. There was a lot of reminiscing and an interchange of encouragement. Mr. James R. Dezell, Sr. of Coral Gables treated all of us to a delicious lunch at Phyllis's Café. After lunch it was back to The Dezell House to finalize the arrangements for the afternoon program. A crowd of 50+ was in attendance as the event got underway. After welcoming speeches from Greensboro's current Mayor, Buddy Pitts, and a genealogy report of the Dezell family by Linda Clark Smith, Lynne Layton Poucher thanked the Capital City Bank Group Foundation and their representatives, Jimmy Suber and Walter McPherson, for their funding of the National Register marker. Dr. Ken Davis of Clearwater and Mr. James R. Dezell, both grandsons of James and Maggie Shepard Dezell, honored us with the unveiling of the historic marker. As a surprise in honor of the Dezell family's Scottish ancestry, all present enjoyed listening to William Johnson of Tallahassee as he played the bagpipes in full Scottish attire. Shirley Clark had arranged refreshments which were enjoyed by all. Please notice the marker the next time you are in Greensboro.

RAISING \$\$\$ TO ACCOMPLISH OUR GOALS

Plans and permits are being finalized for bidding the re-roofing project at the Dezell House. This project will be completed by June, 2007. The firm of Manausa Lewis & Dodson Architects, Inc. of Tallahassee was chosen to work with us through the bidding and permitting process as well as overseeing the construction work. Randy G. Lewis, AIA, will be spearheading the project. We are glad to have Randy on board since he has plenty of experience with all of these facets of historical restoration. This project is being funded in part by the Florida Department of State, Bureau of Historical Preservation, in conjunction with the Florida Historical Commission.

As was reported in the last newsletter, WGHS was one of 129 applicants vying for historical preservation dollars through a special category grant application submitted to the Florida Department of State in June, 2006. The application reviews took place in September. The Dezell House was ranked #57 in the list of projects. Using the same dollar amount that was requested during the last budget year only allowed 53 projects to be funded. Now is the time to speak to your legislators encouraging them to allocate more funds for historical preservation. WGHS would benefit from this greatly. McLANE FAMILY MASSACRE - 1840

The Society's October monthly meeting highlighted one of the most historic tragedies in the history of Gadsden County. The family of John S. McLane, with the exception of his step-son & nephew, John Kenzie McLane, was savagely attacked at their homestead in the early morning of April 23, 1840. The location of the massacre was only a few miles southwest of Greensboro just off present day State Road 12 (Bristol Highway).

Mr. Hubert "Shorty" Edwards, great grandson of John Kenzie McLane, the sole survivor of this attack, was the featured guest speaker. For many years, Mr. Edwards has been the family historian and has carried his family story far and wide to civic organizations, school children, historical societies, and other interested groups in the surrounding area. With him that day was his grandson, Kenneth Edwards, who is "in training" to become the future family historian and keeper of the historic documents, photographs, relics, and other items of interest which were on display. In addition to a large crowd of interested folks, approximately twenty-five McLane family descendants from the North Florida area were present and enjoyed sharing family history with each other.

John S. McLane's family was composed of his wife, Nancy Jane; his nephew and step-son, John Kenzie McLane, (b. 1820); niece and step-daughter Catherine (b. abt. 1827); young daughter (b. abt. 1838) and young infant child (b. abt. 1839/40). On that fateful day, Mr. McLane was in Quincy taking care of business matters.

The Creek Indian War was going on in this area of the South. At this particular time, it was known by the pioneers living in this wilderness area, especially those within the vicinity of the Apalachicola River, that a band of Creek Indians from Georgia had been seen in what is present day Liberty County. One family in the lower part of that area near the New River as well as a family near present day Bristol had been attacked.

Early on the day of April 23, 1840, Catherine was already at the barn milking the cows when John left the house to gather herbs from across a nearby field. Soon John heard noises in the woods and spotted a band of 18 Creek warriors in full war costume, armed with guns, scalping knives, bows and arrows running toward the family's house. He screamed for his sister to run toward the house! As John ran in that same direction, a bullet grazed his left shoulder. They both reached the safety of the house and boarded up there with their mother and the two little children. As the morning progressed, Mrs. McLane decided to make a run for it, along with Catherine & the little ones, attempting to reach the Pickett or McDougald settlement, the nearest neighbors who were about four miles away to the east. As John watched, he saw two Indians heading them off. He attempted to fire at the Indians from outside the safety of the house, but was fired upon and immediately after being forced back into the house, he heard the screams of his mother and sister and then two shots rang out and then all was quiet.

Through the agonizing hours that followed, the Indians set fire to the adjacent kitchen at the rear of the house and began throwing blazing balls of cotton onto the house roof but the cotton rolled off the steep roof without igniting it. The wind shifted during the time of the kitchen fire and directed the flames away from the house in which John was barricaded in his defense against those savages.

Through the holes cut into the logs of the house, John watched one Indian who carried a torch as he skulked from tree to tree while headed toward him. When the Indian was within 20-25 feet of the house, John pulled the trigger of his musket. He then heard the most unusual screech and yells and was aware that it must be the Indian's death scream. The warrior staggered away, with the help of others. Soon the silence was broken by a low chant and it seemed to John that all the Indians had gathered around the wounded one. From the type of noises he was hearing, John believed that the Indian he had shot was either a chief or the son of a chief.

In the later afternoon as the Indians were performing their death ceremonies, John spotted his father returning and ran out to signal to him to keep quiet because Indians were around. Mr. McLane hurried off to find the bodies of his wife and children, but to no avail that afternoon. John jumped on a mare and headed east toward the Pickett or McDougald settlement and was fired upon by the Indians, but soon out distanced them. He reached those nearest neighbors about dusk, soon followed by his father. A courier was immediately sent to the camp of volunteers near Jackson Bluff and by the next morning some of those volunteers arrived back at the settlement. The volunteers as well as Mr. McLane, John, and many others went back to the family homestead. The murdered bodies were soon located. The volunteers as well as U.S. Army regulars made an attempt to locate the Indians, but their escape had been made good.

Some time later when a treaty was made and surrender took place, an old Indian chief said through an interpreter that a white boy had killed his son on the Telogia Creek, and had it not been for his death, the war would have continued. To quote John Kenzie McLane during his elder years – "So you see I may say that I was the cause of the Creek war coming to an end."

Following the massacre, Mr. McLane and his step-son, John, enlisted in the U.S. Army forces in Florida to fight the Indians. Later while serving in the Confederate Army, John carried the same old musket he had used to defend himself and his family.

Mrs. McLane was shot, Catherine was shot and scalped, and the two young children were killed with pine knots. They are buried in a common grave in the Sycamore Cemetery, several miles west of Greensboro. About 1895, John Kenzie McLane was interviewed by a traveling Methodist preacher who wrote down their conversation. These facts were later given to S.W. Anderson of Greensboro and Quincy, and they were subsequently published in the *Gadsden County Times* on January 30, 1936. John Kenzie McLane, hero, died 10-26-1904 and is buried in the Pine Grove Cemetery not too far from the family homestead.
