

SECOND AMENDMENT TO MASTER AGREEMENT - 2016
THE ROUND UP CLUB DBA WICKENBURG CHAMBER OF COMMERCE

This Second Amendment to Master Agreement (this "Amendment") is entered into by and between the TOWN OF WICKENBURG, an Arizona municipal corporation ("Town"), and THE ROUND UP CLUB DBA WICKENBURG CHAMBER OF COMMERCE, an Arizona nonprofit corporation ("Chamber"). The Town and the Chamber are collectively referred to in this Amendment as the "Parties," and each is sometimes referred to as a "Party."

RECITALS

- A. Chamber and Town are parties to that certain Master Agreement, dated August 7, 2012. (the "Agreement") and that certain First Amendment to Master Agreement, dated July 21, 2014.
- B. The Parties now desire to amend the Agreement in accordance with the terms and conditions set forth below.

AGREEMENT

NOW, THEREFORE, in consideration of the mutual promises made in this Amendment, the Parties agree as follows.

1. Incorporation of the Recitals. The foregoing recitals are incorporated herein by this reference.
2. Mobile Stage. Section 1.1.5 of the Agreement is hereby deleted, and the following inserted in its place.


1.1.5 Town owns and operates a Mobile Stage available for rent to organizations within the Wickenburg Town limits. Town shall, at no cost to Chamber, deliver and remove the Mobile Stage for the Special Events identified in Section 1.2.1 of this Agreement. Chamber shall pay Town, at the standard rates and fees set by the Wickenburg Town Council, for delivery and removal of the Mobile Stage for any events other than those identified in Section 1.2.1 of this Agreement. Chamber shall, at all times, comply with all policies established by Town regarding use of the Mobile Stage.

3. Miscellaneous. The balance of the Agreement is hereby amended to reflect the purpose of this Amendment. The Parties hereto acknowledge that except as expressly modified hereby, the Agreement remains unmodified and in full force and effect. In the event of any conflict or inconsistency between the terms of this Amendment and the Agreement,


the terms of this Amendment shall control. Unless otherwise expressly defined herein, terms in this Amendment shall have the same meanings assigned to such terms in the Agreement. This Amendment may be executed simultaneously or in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same agreement.


