Motion by Smock, seconded by Leuchs to approve the agenda. Ayes: all, carried. Council reviewed minutes of 03/15/2021, March list of bills to be paid, March 2020 treasurer's report, Feldmann, Reiter, Kramer, Gassmann, Burger (x2), and Wolfe Building Permits and a Cigarette Permit Renewal for Morning Star Gas Station. Motion by Lueck, seconded by Engler to approve the consent agenda. Ayes: all, carried.

Citizen Concerns: Wayne Oberbroeckling stopped in prior to the meeting and requested to be removed from the agenda.

Paul Engler with Engler-Oberbroeckling Insurance provided and update with the City insurance. Motion by Smock, seconded by Lueck to renew insurance with Engler Oberbroeckling Ins. Mayor Langel called for roll call. Ayes: Smock, Lueck, Engler, Leuchs. Carried.

Water/wastewater: Joe Bonert spoke to council and advised he spoke with Dubuque County to get adjacent parcels combined and that he will be installing a new sewer line prior to building his garage. Bonert advised new sewer line would be going East to connect to main sewer line. Council agreed Bonert did not need a permit to connect to main since they are aware of it.

Public Works: Manternach and Luechs discussed heaving sidewalk and bridge issue with council. Langel advised he would contact Adam McElmeel to get an estimate on prices for concrete work.

Memorial Hall: Burger advised first event went well except sheriff was called by a neighbor making a complaint that there was too much noise and too many kids playing in the park.

Other Business: The council discussed the Dubuque County Sheriff Contract, refuse contract with Roling Sanitation, building permit verbiage addition, Iowa DOT agreement, and the first pay application for Dave Schmitt Construction. Motion by Leuchs, seconded by Engler to approve contract with Dubuque County Sheriff Department as written. Ayes: all, carried. Motion by Leuchs, seconded by Smock to approve refuse contract with Roling Sanitation. Ayes: all, carried. Motion by Smock, seconded by Lueck to approve the addition of the following verbiage to the City Building Permit: "In addition, the issuance/approval of this permit does not in any way, confirm property lines. Determining property lines must be done by a licensed surveyor". Ayes: all, carried. Motion by Leuchs, seconded by Lueck to approve the Iowa DOT Agreement for *Maintenance and Repair of Primary Roads in Municipalities*. Ayes: all, carried. Motion by Smock, seconded by Lueck to approve pay application #1 to Dave Schmitt Construction in the amount of \$113,504.17. Ayes: all, carried.

Updates: Manternach advised a previous citizen failed to appear to court regarding their dog running at large and judgment in amount of \$1,500 was entered, Beau Timmerman and Matt McPherson are scheduled for Sunday July 25th from 1PM-4PM for Music in the Park, and tickets are officially being sold at City Hall for Tracy Byrd and Mike and the Moonpies.
