DISPOSAL OF OBSOLETE EQUIPMENT

The Board of Trustees of Jefferson Township, Montgomery County, Ohio met in regular session on the 4th day of October 2016, at 7:00 p.m. at the Township Offices located at One Business Park Drive, with the following members present:

Trustee Johnson moved for the adoption of the following Resolution:

WHEREAS, The Ohio Revised Code Section 505.10 provides that the Board of Trustees may dispose of equipment it finds is not needed for public use, is obsolete, or is unfit for the use for which it is intended; and

WHEREAS, The Jefferson Township Board of Trustees finds that the following Road Department equipment is no longer needed for public use, is obsolete, or is unfit for the use for which it is intended:

WHEREAS, The Ohio Revised Code in Section 505.10 provides for when the value of property to be disposed of exceeds twenty-five hundred dollars the sale must be by public auction with a three week public notice;

WHEREAS, The Jefferson Township Board of Trustees find that the equipment on this list individually has a value of less than twenty-five hundred dollars, and therefore does not need to be put on public auction, and

WHEREAS, The Jefferson Township Board of Trustees does not have a current valid title to these vehicles making it impossible to sell at a public auction, and limits the sale to a vehicle for parts only

NOW, THEREFORE, BE IT RESOLVED, that the Jefferson Township Board of Trustees approve the recommendation of the Administrator to dispose of the listed equipment consistent with Ohio Revised Code 505.10(A). and authorizes the Administrator to negotiate a sell to interested parties.
