The Mayor and Board of Aldermen of the City of Ville Platte met in a regular session in the Council Chamber in City Hall, 126 E. Main St. Ville Platte, LA on <u>Tuesday, April 12, 2016 at 5:00</u> PM the council meeting was called to order by Mayor Vidrine.

Roll called by City Clerk Shountilez Williams announced that we have a quorum.

Following the Invocation by Girl Scouts Savanna and Pledge by Bethany and roll call by the Shountilez L. Williams, the Mayor and Board of Alderman of the City of Ville Platte were duly convened as the governing authority of the City of Ville Platte.

New Item added to the agenda: Chief Neal requesting the hiring of police officers. It was moved by Councilman Joseph and Councilman Sam. In Favor: All Against: None Motion Carried

It was moved by Councilman Sam and seconded by Councilman Perron to approve the minutes for March 15, 2016 as presented. In Favor: All Against: None Motion Carried

Monthly report for March 2016

The expenditures for the month of <u>February \$216, 348.81</u> and the expenditures for the month of <u>March</u> were \$307,186. 46 the city spent \$90,837.65 more in the month of March than in the Month of February, this is attributed to several major repairs to sewer system, collapse water line, and a down well.

911 Intergovernmental Agreement: (see attachment)

It was moved by Councilman Perron and seconded by Councilman Sam to approve the 911 Intergovernmental Agreements between the City of Ville Platte, Fire District and the Communication District. The City of Ville Platte will pay half (1/2) and Fire District Two will pay half (1/2) for a total of \$1059.47. The city's cost would be \$529.73 monthly. This agreement shall be for a period of one year. After one year the agreement will be revisited to find out how many calls that were taken. Without this agreement, the city's fire rating would be reduced by 10 points.

Sales Tax Comparison

The City of Ville Platte has an increase of 4.86 % from February 2015 to February 2016.

City's Minimum Wage Increase

It was moved by Councilman Dardeau and seconded by Councilman Joseph to increase the employees minimum from \$7.25 to \$8.00 per hour, effective September 2016 or before, with hopes of increasing it again in 2017. In Favor: All Against: None Motion Carried

Employee's Salary Increase: It was moved by Councilman Joseph and seconded by Councilman Sam to approve the 3% salary increase for all City employees.

The City's Medical Insurance (Blue Cross/Blue Shield) has gone up by 8%, effective May 1, 2016, but the city will absorb the cost of the increase and not pass it on to the employees. The drug potion of the insurance will not have a deductible. They are also looking for dental and vision insurance that will cut the cost to the employees.

New Item added--Police Hire:

It was moved by Councilman Joseph and seconded by Councilman Sam to approve the hiring six full time police officers, part-time police officer and a part-time dispatcher, if they meet all of the city requirements.

WHEREAS, the City of Ville Platte, State of Louisiana, previously passed a resolution to become a participating political subdivision of the Authority in accordance with the Act; and

NOW THEREFORE, BE IT RESOLVED by the governing authority of the City of Ville Platte, State of Louisiana, acting in such capacity;

SECTION 1. Approved the appointment of Mayor Jennifer Vidrine to serve as Director of the Authority for a term of two years from the date hereof.

SECTION 2. This resolution shall take in effect immediately and a certified copy hereof shall be forwarded to the offices of the authority.

• Fire Chief's Report – Chris Harrison

• Chief of Police's Report-Neal Lartigue

For the month of March 2016 there were a total of 673 calls in which 591 required reports. There were a total of 99 arrests include (13) felony arrests (47) motor vehicle accidents and wrote (47) citations.

• City Engineer's Report—Ronnie Landreneau

City Engineer Ronnie Landreneau reported that he is currently working on several small projects with the Mayor and Council. The City had major sewer problems that had not been planned for. Councilman Perron thanked Ronnie for his help on Washington St. Councilman Jack addressed the water leak in Court and Edward "Knotoe" Thomas St.

• Mayor's Report-Jennifer Vidrine

Mayor Vidrine purchased 6 vehicles and plan on purchasing 5 more in the future. She is currently working on street signs.

- The Mayor is also looking to purchase a dump truck and five more vehicles.
- The city is currently replacing street signs and street lights.
- The basketball courts have been delayed due to the weather.
- The City will be getting new software next month with brand new programs.
- The Ville Platte Youth on the Move still taking application until April 15, 2016.
- The Mayor is still in contact with the Hotel Chain.
- The Boys and Girls Club will be opened to all kids, parish wide.
