A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF JUPITER INLET COLONY, FLORIDA, APPOINTING A VICE-MAYOR; PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE AND AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, Article III, Sections 10 of the Town Charter and Section 5-10 of the Code of Ordinances of the Town provide that the Town Commission shall meet annually as soon as practicable following a general election for an organizational meeting; and

WHEREAS, the Town's general election was scheduled on March 9, 2021. Groups 1, 3 and 5 were scheduled for election. No election was held since all candidates as follows were not opposed for election: Group 1: (Mayor) Daniel J. Comerford, III; Group 3: Lisa H. Hines and Group 5: Richard D. Busto; and

WHEREAS, on March 22, 2021, the Town Commission held its annual organizational meeting; and

WHEREAS, in accordance with Article III, Section 10 of the Town Charter and Section 5-10 of the Town Code, the Town Commission is required to appoint a Vice-Mayor at its Organizational Meeting; and

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF JUPITER INLET COLONY, FLORIDA, THAT:
