## CONTRACT FOR SERVICES RENDERED

THE PARTIES TO THE BELOW FOREGOING CONTRACT ARE AS FOLLOWS:

(Company CEO), (herein referred to as "the contractor" AND

### COMMENCEMENT

1. This contract shall commence on (Date). Completion date shall be approximately (Date)
2. DESCRIPTION OF SERVICES: The contractor shall provide the following services for said client and build one (1) fully functional new 2014 Lamborghini Aventador LP700 REPLICA with specifications noted below.
3. Paint Satin Black, as requested by client.
4. Satin black five star rims, 19" in front and 20" in rear.
5. Shall have functional air-conditioner and heater.
6. Shall have back up camera.
7. Shall have working windshield wipers.
8. Shall have custom door poppers, this will be controlled by a hand held remote popper.
9. Shall have custom remote start, this will also be controlled by remote, same device that controls the security system.
10. Shall have custom LED lighting inside car placed under dash.
11. Shall have custom matching OEM interior, interior shall be black with French braid stitching.
12. Shall have custom installed 7" LCD touch screen with navigation built in. Camera will also run through stereo screen so as to have large picture when in reverse.
13. Shall have full power windows.
14. Shall have custom installed security system, this will run off remote that controls poppers for doors and engine start.
15. Shall have custom v6 motor with automatic transmission.
16. Shall have custom air ride suspension in front, (Air Bags).
17. Stereo shall have AM and FM stereo, with CD player.

It is agreed by both parties that the Contractor shall have control of how these services will be performed subject to it meeting the standards as required by said client.

The contractor warrants that no laws will be violated in performing any of said services within this contract.

The contractor warrants that he is not violating any other agreements or contracts of any kind by performing these services.

The contractor guarantees that (he) is competent to carry out the services (he) has undertaken in this contract. Any material misrepresentations shall lead to a summary termination of this agreement.

### PAYMENT

The contractor will be paid on the following basis:

The total price for this project is \$32,000 and not to exceed said amount.

Client shall pay the amount of \$20,000 dollars in the month of April 2014 for the construction of said Lamborghini replica. Client shall pay the amount of \$5,000.00 per month over a period of two (2) months. Also in additional amount of \$1,000.00 at some point within two weeks of the completion date of the replica. The amount of a 1,000 deposit t for contract shall be paid today in full on (Date) and is non-refundable. This amount does go towards the car.

The contractor and client both agree that (they) hold the right to withhold services or payment if contractor or client fails to comply with said terms of contract.

**OBLIGATION OF THE CONTRACTOR**

**Shall provide donor car vin# XXXXXXXXXXXX Client shall take possession of said title today on (Date) but not take possession of said replica car until completed and paid in full.**

- 1. This agreement and any exhibits attached constitute the sole and entire agreement between the parties here within said contract with regard to the subject matter hereof and the parties waive the right on any alleged express provisions not contained herein.**
- 2. Should the contractor (Company CEO) fail to deliver the finished product in a timely manner as promised; the client has the right to ask for a full refund in a lump sum. It is further agreed that if the total is not returned to the client within (15) business days the client has the right to seek all legal avenues to resolve this matter. The contractor further agrees that (he) will be responsible for any attorney's fees and all court and out of pocket expenses sustained by the client.**
