

## Client-Practitioner Agreement for Emotional Release Work

**Cancellation Fee:** I agree that if I cancel my session **LESS THAN 24 hours** of our agreed-upon session time appointment, I will pay a \$50 late cancellation fee to Colleen **BEFORE the date of our rescheduled session appointment.**
