

Dead Man files Paper in Court – Contempt of Court Events

The dead former husband's attorney filed a contempt of court against me shortly after the former husband had died. The contempt stated that I needed to return some vehicles as stated in the Divorce Decree. In this case, a dead made an appearance in court! But they had never requested arrangements to return the vehicles. Despite the fact as documented in the Police reports 2012-00020087, 2012-000200733, BP-10-01273, my former husband broke into the house and took the motorcycles and furniture he wanted and he left the vehicles that were mine. Even though he left the motorcycles he did not want, the court had awarded all motorcycles to him. Three of the motorcycles were actually customized for me and rode by only myself. Moreover, the judges are against the rule of law so they are together trying to take advantage of the situation and put me in jail? However, they failed to reliably pay the alimony for over 4 years and fulfill the court order regarding my pension through QDRO (ordered on 09/19/2012). I did not refuse or fail the Court orders.

Newport filed the contempt and to punish me. As an attempt to put me in jail? The Judges and lawyers were against the Law so as to why these judges and lawyers together try to bind me. As they did 25 years ago, put an innocent person in jail, as a scapegoat for their political ambition. **Are they using the Hawaii Property Proceeds as a war chest (see "Is This Iowa Justice?")?** Now, they demand I pay their lawyer fee?

The below description of events point out that even though on the surface this looks like an one-sided contempt allegation, the actual objective was the capture of June. The three events related below all show, conclusively that the opposition and the court were trying to set June up for capture and imprisonment.

The reason why they pursued June was to through her off the receipt of the QDRO.

Pre-Trial Conference

August 29, 2103

This conference took place just days after June's release from the hospital on August 24, 2013. She had been hospitalized due to stress, exhaustion and dehydration since Koenig had not filed an appearance until the day before the pre-trial conference. June had requested that this conference be postponed since she was not feeling well. However, Koenig (my lawyer) declined her request for continuance.

Newport (dead former husband's lawyer) delivered to Koenig the draft quit claim deed for the IA house and the QDRO. (After over 2 years of Court orders they failed to file). Quit claim deeds for the camera corner property and the Florida were also presented and June signed both. June also signed over CD's held in Muscatine Bank.

The subject vehicles of the Contempt allegation that June had any current knowledge about include: the RV, Yamaha Motorcycle, Triumph Motorcycle and the Harley-Davidson Motorcycle in California. The three motorcycles were ridden and maintained by June. Tom had never used them and in fact left them with June when he broke into the Bettendorf house to recover other property. The Harley was heavily customized to fit June.

The key to the motorhome was delivered to Koenig the day before and he gave it to Newport.

We had proposed to meet Newport's representative in Chicago later that day to turn over the Triumph Motorcycle. Newport stated he could not go to Chicago on that day. After much pressure to go over the next weekend, which was Labor Day weekend (traffic would be heavy and bad), everyone agreed to meet on September 7, 2013 at 1:00 PM to deliver the Triumph Motorcycle. After checking his phone, Steve Newport gave his cell phone as 309-349-3912. He did not know his cell phone number. Brian Gilmore repeated it back to him and he acknowledged that is the correct number.

The attorneys set the next day, August 30, 2013 to pickup the Yamaha Motorcycle at 11:00 from June's Bettendorf house. Of course this is in the middle of the workday.

Newport agreed to send the date and arrangements to pickup the motorcycle in California. (As will be shown later, he never did make those arrangements)

Yamaha Motorcycle Pickup

August 30, 2013

Bettendorf, IA

On the morning of August 30, 2013 June sent a txt message to Newport's cell phone stating that she could not make the 11:00 appointment and asked for it to

be reschedule for 4:00 pm, that day. She sent directly to Newport “August 30, 2013, 9:28 AM Mr. Newport, unfortunately I will not make 11:00 AM today but I will or someone will open the garage door so you will certainly have access to Yamaha at 4:30-40PM today. As you know I was on the brink of death at the hospital last week and also needed to stay in more but did not since I do not have health insurance No matter you guys do not care, but I have to take care of my health “ “even I will not make exactly 4:30-4:40 Pm,. Someone will open the garage door for you, the Motorcycle key is in your hand” Message to Attorney Mr. Newport??”. June had still been recovering from the hospital and suffering from swelling, pain, diarrhea and vomiting. She was overall incapacitated and was sick in the bedroom. Mr. Newport did not respond to the txt message. At 11:00 reportedly by Koenig, Lawyer Newport shows up at June’s house and claims he cannot gain access. Reportedly, he calls the Judge and Police to gain access to the property and pick up the motorcycle. After 11:00, The Police searched the house. June was sleeping but heard the commotion and after diarrhea, did not even flush the toilet and took refuge in the basement closet. On the way to the closet, June had left a Bible and Cross on the floor. During their search, the Police did not cross the safety zone created by the Cross and Bible. This occurred around 12:20 PM. After an extensive search of closets, bedrooms, surrounding woods, and returning to the closet several times, the Police did not find June and everyone departed the house with the Yamaha motorcycle around 1:30 PM. Obviously, the Police and the Lawyer Newport’s objective was more than the recovery of the motorcycle, but possibly also the capture of June.

Triumph Motorcycle Pickup

September 7, 2013

As mentioned above, the Triumph motorcycle was to be picked up by Newport at 1:00 on September 7, 2013.

These arrangements were confirmed in a letter to Koenig dated September 2, 2013. The letter gave the address for the pickup and provided Newport with the address for the storage facility holding the RV as well as the access code. Concurrent with this letter and CC to Koenig, The storage facility was informed of the event and asked to provide Newport the same privileges as a customer with access to the facility and the code. This letter was sent via certified mail.

The location for the pickup was June’s Sheridan Avenue, Chicago, IL condo.

On September 7, 2013 at 12:40 PM, June was still sick and not fully recovered from her hospitalization. June and Brian arrive at her condo to deliver the motorcycle and removed it from the garage. As of 1:00 pm, no one appeared. After over 3 hours of waiting, a person by the name of Wes Fuller, actually Newport and he himself referred to him as Bulldog. What is Bulldog? He had a non-descript pickup truck and carried no business sign on his truck. Newport called to say that Wes Fuller was his representative. Brian made several phone calls, and txt messages to Koenig and Newport's office. Newport's cell phone rang to a phone and they said they did not know Newport. During the time we had waited, we did not receive any calls from anyone explaining the delay. Wes Fuller excused his lateness by saying there was a major traffic tie-up due to an accident on the Highway, but he was sketchy about where it happened and thought it was west of Rockford, IL. Wes Fuller had come from the Quad City area earlier in the day. A check of the Illinois State Police website, June's Chicago Bike Club Member who is a Chicago Police Sargent and Google Traffic showed there was no major accident and no traffic delay. We asked if they had stopped by the storage facility to get the RV and they had not, that would be next. Wes Fuller also informed us that he had been in prison in the State of Georgia for assault and Battery and served 5 years. A receipt was obtained from Wes Fuller. At about 4:20PM, Wes Fuller and a colleague loaded the motorcycle into his pickup and left. We were afraid that if we left before they arrived, then Newport would have called the Police to arrest June.

On September 9, 2013 Brian delivered the Yamaha keys to Koenig and informed him of Wes Fuller's violent and criminal past. He told Koenig to tell Newport not to send another con next time that he was mad at Newport for sending an ex-con (from a violent) offense to June's Condo. Koenig even admitted that Fuller must have beat the other person close to death to warrant a five year sentence.

Upon arrival back in Bettendorf, June sent a letter, dated September 10, 2013 to Koenig informing him that she will be in California on Oct 4, 2013 to deliver the Harley. In this letter she also informed Koenig that Wes Full was a convicted felon and requested Newport to send someone who is not a convict and is reputable to the California meeting.

Harley Motorcycle

In a letter dated September 2, 2013, June Hong had informed Koenig that she will be California on Oct 4, 2013 to deliver the Harley to Newport.

Koenig did not provide any response or confirmation to this letter.

June Followed-up with another letter to Koenig dated September 10, 2013 requesting Koenig and Newport to confirm the October 4, 2013 meeting. This letter also requested Newport to send a reputable representative. There was not response to this request.

June sent another letter to Koenig dated September 23, 2013 requesting conformation for the Oct 4, 2013 meeting. It was also proposed to set the meeting time at 10:00 AM at the Extra Storage Facility in Walnut Ca. Again a request was made for Newport not to send a felon. An offer to purchase the Harley was included in this letter, but that offer was declined.

June sent another letter to Koenig dated October 1, 2013 setting the date, time and location of the meeting as stated in the previous letters. Since no response had been received to the above proposals, the letter stated that the meeting would take place on Oct 4, 2013, at 10:00AM at the Extra Storage Facility as stated in the previous letters. A final request was made for Newport to send a reputable representative since we were at a remote site (out of town). No response was received from this letter.

June still suffering from poor health: swelling and pain, arrived in California on Oct 2, 2013 and proceeded to the Extra Storage Facility the morning of Oct 3, 2013 to open the locker, inspect the motorcycle, dust it off and do general locker clean up. At about 12:00 noon, her and Brian left for lunch. After lunch, June received a voicemail from Koenig's secretary stating the Newport's office called and reported the Harley was left outside and they wanted it secured because they were concerned it would be stolen. The motorcycle was not taken out of the locker and was still inside the locker at this time. The only person who was aware of June's presence on the facility was the manager Nadeem Tabani since she had talked to him shortly before going to lunch. We returned to the extra Space Facility and confronted Nadeem, he denied calling Newport, despite the sticky on his desk with Newport's name and number written on it. He denied any connection and said he only rented the locker. As discussed below, we talked to Koenig's secretary in front of him. Nadeem said he was not going to answer anymore questions and had nothing more to do with this unless it involved renting a locker.

We called Koenig's secretary to tell her that the motorcycle was not outside and that we were offended she would support such a false accusation. We asked them to make arrangements to get Newport to pickup the motorcycle since Newport's locker was up a steep hill that neither June nor I could push the 800

pound bike up that hill. June sent Koenig a picture of the driveway and the steep hill leading to Newport's locker. Brian also told Koenig's secretary that June's responsibility ended once the motorcycle was outside of her locker. She agreed as Koenig had agreed to that earlier as well. Koenig's secretary was extremely defensive about the whole matter. Brian had to remind her that she needs to be working for June since June is Koenig's client and not Newport. She said she would present the problem to Newport, but we never heard anything more from her. Later Brian called Koenig to ask about the plans for the next day. Koenig said to leave the bike outside the locker and secure with a cable. He said that June's responsibility ended at the locker door. Later that night, Koenig sent June a txt message to the contrary saying to not move the bike. We were confused since in a phone call with Brian Gilmore, Koenig had told Brian to just leave it outside. But we believed this was a trick and that the bike would have disappeared, resulting in Newport calling the Police to arrest June.

On the morning of October 4, 2013, June and Brian arrive at the storage facility at 9:00 am. Upon arrival, June asked Nadeem to sign a note stating that he did call Newport and tell him we were there and the motorcycle was left outside. Nadeem became very defensive (and insulting), refused to sign, stated he was done and walked away.

At 10:00, October 4, 2013, no one shows up to move receive the motorcycle. This was report to Koenig along with a re-assertation of the fact that we cannot physically get the bike up the hill.

At 10:15 Koenig told Brian via phone to go to HomeDepot and hire some labor. Brian countered with Newport looking up movinghelp.com to send labor out the facility since it was his responsibility. Koenig said Newport would not like that but would ask anyhow.

Brian and June went to Home Depot and found day labor but were concerned about the safety and the ability of the people there since they looked like street people.

Brian then tried to get on line with moving help.com and since he was working from a smartphone had trouble but placed a call to them, they move only household items.

At this point Brian sent a txt message to Koenig asking him for help to get some labor. This was at 11:10 AM, Oct 4, 2013.

June asked others for help: Joe (a local biker we met the day before), her former church and the local Police.

Just about 1:00 Koenig called and said Newport will be sending Haddick's out to retrieve the bike at 2:00 PM.

Between 1:25 and 1:45 we requested the manager Nadeem Tabani to record the meeting and he refused saying he had nothing to do with this. He had at the same also closed and locked the office door. A call to the Extra Space customer service revealed that they have a recording going all the time and if something happened they could access it.

At 1:45 PM, Brian called the local Police and requested their presence to document the transfer and to provide protection should Newport's representative have a criminal past.

At 1:58 PM the motorcycle was removed from the locker and placed outside.

At 2:00 PM, no one arrives. Shortly after 2:10, a white truck arrives at the gate, but does not enter.

2:22 PM, Haddicks arrives. We cannot let him in since we do not know him and apparently Newport did not give him the passcode to his locker. A receipt is obtained for the motorcycle. June, actually facilitates his entry by telling him to follow the car in.

2:30 PM, Newport called Brian to confirm his representative.

2:35 PM, Police arrive and Brian explain the events to the Police. They take a report and leave.

Shortly afterwards, Brian called Koenig to inform that Newport's representative had picked up the bike to asked for the contempt to be dismissed now.

Closing

Subsequent to these events, June signed a limited Power of Attorney for Newport to transfer the vehicle titles to his clients. However, what specific vehicles are called out in Exhibit 6 of the Divorce Decree is uncertain since it has never been seen. About the week of November 13, 2013, through much pushing and insisting, June received a dismissal of the allegation.
