## Leasing Your Home? Read on....

In accordance with Scottsdale Ranch and Casa del Cielo's CC&Rs, an owner of a home that is being leased must submit a tenant registration form to the Casa del Cielo HOA and Scottsdale Ranch Community Association.

If you are leasing your home and have not submitted a Lease Notification Form or we do not have a current form on file, you can find the form on our website under Documents. <u>Lease Application Form</u> You can also contact us via at <u>casadelcieloscottsdale@gmail.com</u> or leave a message at 480-767-

5940 and we will be happy to email a form to you. If you have a management company overseeing your property, please provide that information.

If we don't have an updated Lease Notification Form or Tenant Registration Form on file, Casa del Cielo HOA will be notifying homeowners we believe to be leasing their homes for an updated form. Failure to submit a tenant registration or Lease Notification Form within a timely manner is considered in violation of both Scottsdale Ranch and Casa del Cielo CC&Rs and is subject to a fine by the board of directors.

# **Community Pool for the Community**

We're fortunate to be living in a community that has a pool and spa for residents and their guests to enjoy. Please be considerate and respectful of others using the pool. So that we can continue to keep the pool and spa clean, and the pool area looking nice—please follow the <u>Pool Rules</u>.

**Reminder:** There is one pool key per household. If you lose your pool key, it is \$25 to get a replacement. For the safety of residents, pool keys cannot be duplicated.



## **Light Poles Around Casa del Cielo**

You may have noticed the light poles around Casa del Cielo are being painted and taped at the bottom to protect against future rusting and deterioration. In two cases, we have had light poles that needed to be replaced due to rusting. Thank you to Mike Zoretich, ACC Chair, for his help working with APS to get them painted or replaced.

The light bulbs in our street lights are also being replaced with new LED lights. LED lights are safer, more energy efficient, provide brighter light, and have a longer lifespan.

Next, we'll be looking into the maintenance of the utility boxes on properties throughout the community. ## Mailboxes, Light Poles, Stop Sign Poles

Please do not tape flyers or signage to the mailboxes, light poles, stop signs, or other community poles in Casa del Cielo. If we see flyers taped on these devices, they will be removed. Taping fliers, over time, destroys the paint on the mailboxes and poles. Please help us keep our community looking beautiful!



# **Rules for Campaign Signage**

In case you haven't heard, we have an election coming up! If you're planning to display signage, please follow these guidelines:

Campaign Sign Owners may display political signs no more than 71 days before an election only on their front yard property. No signs are permitted in common areas, including the pool and community entrances. All campaign signs must be removed within three days after the election. Signs must conform to local ordinances and any Scottsdale Ranch requirements.
