Klocke reported that letters were sent to Country Club Acres' residents regarding connections to Lambs Grove sewer. At the January meeting, a public hearing date will be set for the City's sewer project.

Slothouber moved and was seconded by Friedman to approve Resolution # 2012-06 to authorize, approve and secure the payment of a \$61,400 Sewer Revenue Loan and Disbursement Agreement Anticipation Project Note for the planning and design of the City's sewer system. Ayes: Friedman, Slothouber, and DeGoey. Absent: Clark and Parsons.
- b. Clark moved and was seconded by DeGoey to accept Karl Peters' bid to replace the Emerson Hough Drive storm sewer pipe for a cost not to exceed \$7,443. Upon roll call vote, motion carried unanimously.
- c. Clark moved and was seconded by Parsons to accept Ed Machin's bid for a cost of \$7,700 to replace the storm sewer intake and pipe at discharge on Waterbury. Upon roll call vote, motion carried unanimously.
