

### **Adoption Process**

The first step to a successful TROTT adoption is to submit this application, which helps us understand your horse experience, the discipline you ride, and the criteria for your match.

After submitting the application, you can make an appointment to meet the horses who meet your criteria. Currently the ones in training are located at our Orange County, Ca. barn.

TROTT horses are **NOT** rescue horses. Our horses are high quality Thoroughbreds coming from the major racetracks in California. TROTT is a nonprofit for retraining racehorses, and provides a lifetime safety net for our horses. We work hard to ensure our horses never disappear, and never become rescue horses. We look for adopters who share our mission.

TROTT horses have been given top quality care, with a foundation of groundwork, and under saddle training, so we can assess their talents for a new career--although most are still considered green. We look for homes with OTTB experience, or those who have a trainer with OTTB experience.

### **Pricing:**

We have horses in all price ranges. Price does not determine the quality of the horse. The need to place the horse and make room for another one, along with the amount of training invested, determines the price. Horses are only placed when we think it is a good match.

Most prospect horses are priced at \$3,000-\$5,000. Horses with restrictions, limited to flat work, or pleasure homes, are priced accordingly. Sound horses able to compete at the higher levels may cost \$5,000-\$10,000+. TROTT is not a broker selling horses, and we will only place a horse with someone we consider to be the right match.

If we really like the match, we will make it happen. TROTT horses are our special horses, and they will only go to people we feel will love them as much as we do. We do not get our horses from rescue situations, or low end tracks.

When you come to visit, our trainer will first ride the horse. After seeing the horse shown, you will have the opportunity to ride him under the guidance of the TROTT trainer. If at any time we see you and the horse are not a match, we will stop the ride, in order to keep everyone safe.

### **IMPORTANT NOTE:**

If your budget can't buy the horse you want, we suggest you wait and save up. It costs the same to feed a \$2,000 horse, as a \$5,000 horse. Wait and get the horse you want.

We encourage you to be sure the horse vets out for your chosen discipline. Any records and scans will be copied to TROTT, and will become the property of TROTT.

We need to know your budget, so we can show you the horses who will be in your budget range. **All** questions must be answered, and a release of liability form will need to be signed by everyone who comes on the property.

### We will only show you horses who fit your goals and your budget.

Since the purchase price is by far the least expensive part of owning a horse, we do need to ensure our adopters are financially able to provide a suitable lifetime home. We always entertain offers for a perfect match.

**You must answer this question in order to move forward.** (If you submit with no dollar amount, your application cannot be reviewed. "Negotiable", "No Budget", etc. is not acceptable--and your application will be set aside.) If your budget is less than market value for the horse of your dreams, please know that TROTT is NOT a rescue with damaged horses being given away. We are trying to be respectful of your time, and the time of our trainer.

# **17.** Do you understand that this horse may have been raced, and may have had previous injuries?

TROTT will tell you everything we know about our horses. We are trying to make a lifetime placement, with the best match for horse and owner. We always take our horses back should they ever need us.

TROTT does **not** typically have previous vet records, nor do we order radiographs, scans, etc., without demonstrated medical need. Our vet sponsors at the track ensure we take horses who have a future as a riding horse, but we do not invest in scans, ultrasounds, x-rays, etc., without a demonstrated need. If you want to jump competitively, please plan to x-ray legs in the PPE.

We encourage you to get a pre-purchase exam to determine if the horse is sound for your intended use.

The adopter agrees in advance that TROTT has the right to obtain all veterinary records directly from any veterinarian performing a pre-purchase exam, and that execution of this form shall serve as a release to the applicable veterinarian, authorizing the delivery to TROTT all veterinary records maintained.

Lifetime Conditional Bill of Sale: Upon final adoption approval, A Lifetime Conditional Bill of Sale will be required to be signed. The horse may never race again. Follow up site visits may be performed. Although you are allowed to sell, lease or transfer an Adopted Horse, the Lifetime Conditional Bill of Sale means that TROTT will always be given first right of refusal. TROTT hopes to make a permanent placement, but we are committed to being a safety net for all of our horses, should they ever need to come back.

### **TROTT's Hold Policy for Adoptions:**

In the best interest of the horse, TROTT horses are ONLY taken off the market and put on hold, with a NON-REFUNDABLE \$500 deposit. This will take the horse off the market for 10 days while references are checked, and any PPE is done. Adopters can do a Pre-Purchase exam without a deposit, but the horse will continue to be shown to other prospects.

We encourage all prospective adopters to do a Pre-Purchase Exam, and any scans they choose, prior to making a decision, in order to be sure the horse is suitable for their chosen discipline. A copy of any vet records will become the property of TROTT

Reference checks are the final step in the approval process.

TROTT will give you a list of approved haulers, and we strongly encourage you to use one of our trusted shippers for your horse's first trip home. Adopters are responsible to arrange the shipping, and order any health certificates, etc.
