Dear Senator Hill,

With your help, we can end one source of toxic pollution to our lives and our watershed areas by ending broadcast herbicide spraying along our state roadways in San Mateo County. On behalf of hundreds of people who have signed our petition and worked on this issue since 2006, I respectfully ask for your leadership to protect our water resources and public health. This is an urgent matter, as the records attached below show that Caltrans has already broadcast sprayed thousands of gallons of toxic chemicals\* along Hwy. 280 from San Bruno to San Jose in January, February, and March with no public warnings.

Will you please submit a request to Caltrans to NOT broadcast spray herbicides along Hwys. 84. 35. and 1?

Caltrans has not replied to our repeated requests for their plans for spraying these roadways (March 7, 2017 which Ms. Dentler also received). Residents in my community have posted No Spray signs, and every year, we do not know when, where, or what toxins will be sprayed along our properties which include our private drinking water sources. Despite our county supervisors ending broadcast herbicide spraying along our county roads in 2012, this practice continues with Caltrans. People are confounded and angered with this inconsistency, and it is time to leave this toxic method of vegetation management in the past, as many other areas have done successfully.

As Caltrans' own studies on roadside vegetation management have shown, mowing and cutting is most effective for safety, visibility and fire prevention. We are willing to help Caltrans with invasive weed management, as many people have been doing this work in our local communities. We will do much more to help IF Caltrans agrees to end the toxic broadcast spraying.

There are so many forms of pollution that we cannot control, yet this is one that we can, with your help.
