After conducting a nationwide search and interviews, the Clear Creek Amana Community School District board has narrowed the field to three men in their search for the next CCA district superintendent. The finalists are Brett Bunch, Corey Seymour and Matthew Strom. Each finalist will be interviewed by the school board January 25, January 26 and January 31.

Community members are invited to meet the finalists at 5:30 pm on January 25, January 26 & January 31 at the High School Performing Arts Center. Brett Bunch is the Superintendent of the Newport School District in Arkansas. Brett initially pursued a law degree at the University of Arkansas before transferring and graduating from the University of Arkansas at Little Rock with a Bachelor degree in Communications and Marketing. Upon graduation, he moved to Hilo, Hawaii where he was a television news anchor for KHBC for two years. He returned to the mainland and spent the next 20 years as a business executive before becoming an educator. He has a Masters in Educational Leadership and a Specialist degree in Education from Arkansas State University and is currently working on his Doctorate in Educational Administration. Bunch taught AP US History and economics, was a high school principal and has served the past eight years as a Superintendent. Brett is an innovator in education from on-site medical, dental, vision and mental health services for students and staff, to starting the only Conservation Academy in the country. He was recognized as the Administrator of the Year for his work with mental and physical health for his students by the State of Arkansas. He developed a school calendar to better serve minorities and socioeconomically challenged students and initiated an academic compliance counselor to increase the academic rigor and accountability of students during the COVID crisis. His district has stayed ahead of the COVID crisis through strategic planning for technology, additional mental health services for

students and teachers, and developing a partnership with T Mobile to meet the needs of those students without quality internet services at their home by providing them with hot spots.

Dr. Corey Seymour graduated from Rice University, where he was selected as a member of the AFCA Good Works Team and was the Hitachi Promise of Tomorrow Scholarship recipient. He later earned a Master's Degree in Educational Administration from Texas Southern University and a Doctorate from Walden University in Organizational Psychology. He began his career in education with the Houston Independent School District, serving as an English teacher and athletic coach. He later became a K-8 administrator, earning Assistant Principal of the Year and Principal of the Year honors. Seymour took those experiences with him to Cedar Hill Independent School District, where he served as a high school principal and leader of secondary schools. He later accepted the superintendent position for Santa Gertrudis Independent School District. During his tenure, student participation in Advanced Placement and Dual Credit courses increased. The district achieved a 100% graduation rate, and district historic highs in college scholarships. He broadened his career as an Area Assistant Superintendent (Area Senior Director) for Portland Public Schools and as the Executive Director of Leadership for Ector County Independent School District: where he oversaw and supported numerous schools. His career has focused on improving equity and cultural proficiency, implementing diversity mindfulness practices, college and career readiness, developing school leaders, and closing the achievement gap.

Dr. Matthew Strom most recently served as Chief Operating Officer of Queen Creek Unified School District (12,100 students and 14 sites). Prior to this Strom was the Assistant Superintendent of K-12 Educational Services in Chandler Unified (45,000 students and 45 sites) working with Curriculum, Instruction, Research and Assessment. He holds a doctorate degree (Ed.D.) from Northern Arizona

Ironically I would have a SON who was asked to fill in at a ballet recital while in college.

I nearly had a fit because he had no training and he would have to lift one of the girls and walk with her across the stage.

Well it seems he did it anyway and practiced daily for weeks. He actually grew to like ballet which really puzzled me.

When the big day came there he was center stage no less, and I was in a cold sweat. He had developed muscles I had never noticed before and "gracefully" did his moves including lifting the girl.

I was sure a hernia was inevitable, but the ballet coach had taught him well.

Afterwards I congratulated him, but he was too embarrassed to acknowledge his mother.

Years later I would see him at a wedding dancing and wonder if just maybe I had been given the chance I too could have really danced.

University. Arizona School Administrators recognized his work in that program by awarding his dissertation the Dissertation of the Year in 2012. In conjunction with the Center for the Future of Arizona, Strom received a 2021 Arizona State University President's Medal for Social Embeddedness recognizing his efforts to bring Participatory Budgeting to both Chandler Unified and Queen Creek Unified. Participatory Budgeting involves students in allocating budgeted dollars for school improvement projects while promoting civic engagement. Prior to joining district office executive teams, Strom was the Mathematics Department Chair at Basha High School in Chandler, Arizona. His K-12 teaching experience spanned 13 years covering a variety of subjects from AP Statistics to Computer Programming. Strom was born in Boone, Iowa. He grew up in Ogden, Iowa before his father, a 45-year mathematics teacher, moved the family to Phoenix in 1986.

The board conducted the first round of interviews on January 17th & 18th. As a next step, the boards and stakeholder interview teams will conduct final interviews with each of the three finalists. The board plans to reach a final decision soon after the conclusion of the formal interviews. The individual selected will succeed current Interim Superintendent Joseph E. Brown, Sr. who has filled in for the year after Superintendent Tim Kuehl accepted employment as Superintendent for both East Union and Murray School Districts.

Amana Freezer Run Bone Chilling But Winterfest Still Heartwarming

A 15-degree morning with a cold, gusting wind out of the northwest did not stop 156 racers in the Amana Freezer Run from finishing the 5k race which took them from the lower loop of Amana out to East Amana, round the village of East and back into Amana.

Nearly 180 were entered, but 156 crossed the finish line to record their times. West Amana native Nathan Hopp once again claimed the Amana Freezer win with a time of 17:05 besting the second place finisher, Christian Sande of Marion, by nearly 2 seconds. Third place winner Justin Hajek of Marion finished a cool 19:27. Jessie Clark, Cedar Rapids was the overall female winner with a time of 21:56. Winning the 14 and under was Axel Brandsmeier of North Liberty took the boys 14 and under. Conner Duncan of South Amana took second place in that division.

In the girls 14 and under 8 racers duked it out with Ellie Yates and Addison Yates of Sigourney winning first and second place, followed by Kyla

Schulte and Kinsey Schulte both of Amana. In the men's 70 and over division there were 8 racers with Jim Shimek of Fairfax besting the lot with a time of 26:19. Claudia Scott of Marion was the winner of the women's 70 and over division.

The majority of racers came from eastern Iowa and were joined by runners from Richland, Michigan and Coatsburg, IL, to name two of the out of state communities represented.

Checking out the mini golf course Saturday, we were thrilled with both the very cute cuckoo clock putting green and the nifty Maipole putting course. When we were there 4 couples and one large family were playing rounds of golf.

Winners of the 22 Winterfest Beard Contest are as followed: Bob Lynch of Robbins, Iowa was the winner of the "BEST BEARD" award; Fullest Beard was claimed by Ron Dietrich of Marengo. Ryan Paul had the Longest Beard. His measured a full 14 inches. Most unique was Verlen Klerk of Cedar Rapids and the male who has gone the longest without shaving was one Brad Anderson of Oneida who last shaved (fully) in 2004.

Dana Jensen, Amana Colonies Festivals manager, reported that this year's Winterfest was well attended and volunteers agree that while it was colder than last year, the crowd sizes at the Market barn were average or above average when compared to year's past, this is especially notable as last year the temps were in the 30's.
