

Kristy L. Fischmann has entered the race for a seat on the Central Square School Board. Kristy has spent most of her life living in the District, leaving only once to practice law in New York City for a few years.

Following her graduation as Salutatorian of Paul V. Moore's Class of 2000, Kristy attended Utica College of Syracuse University where she studied Criminal Justice and Economic Crime Investigation. She graduated *summa cum laude* with a Bachelor's Degree in 2003, following a capstone internship at the International Criminal Police Organization (Interpol) in Lyon, France. She then graduated *summa cum laude* from Syracuse University College of Law in 2007. While in law school, she served as an Executive Editor of the Syracuse Law Review and received numerous academic honors, including a National Security and Counterterrorism Law Certificate. Throughout her education, Kristy was also an accomplished athlete, particularly on the rifle range and lacrosse field, and received many honors and athletic awards including induction into the Athletic Halls of Fame for both Paul V. Moore and Utica College.

Kristy spent her first three years practicing law in New York City for two prestigious international law firms (Clifford Chance and Skadden). While there, her practice focused primarily in white collar criminal defense, including cases involving financial and health care fraud, anti-trust, and the Foreign Corrupt Practices Act. Upon the birth of her first child in 2010, Kristy moved back home and quickly secured a job with Gale Gale & Hunt, a boutique firm in Fayetteville, New York that specializes primarily in medical malpractice defense. She spent four years there before transitioning back into the white collar criminal defense arena as an Associate of Barclay Damon (formerly Hiscock & Barclay). Kristy has also served as an adjunct lecturer at Utica College where she has taught legal concepts related to the prosecution of economic crimes. Upon her return in 2010, Kristy and her husband Ken built a house and settled down in West Monroe. They have two children (Kenny, age 7 and Katie, age 4) who attend Aura A. Cole Elementary. Since she has been back, Kristy has spent countless hours volunteering at various school and church (Divine Mercy) functions, including participation on the community focus group set up by the School Board in 2014 to aid in consolidation efforts.
