Motion Approve Minutes: Councilman Welsh made a motion to approve the August 17th 2022 and the September 17, 2022 meeting minutes, seconded by Councilman Durland and all were unanimously in favor.

Supervisor Maas asked for a moment of silence for the Strehl Family who suffered a great loss. Councilman Durland explained they lost their young son Jack, earlier in the month and the Town and the community have them in their thoughts and prayers.

Supervisor Report

- Town Board members have received the list of warrants/abstracts; cash receipts, escrow reports, Building Dept. report, performance vs budget report and lists of all deposits made in both the General Fund and Highway Fund.
- The 9-11 Memorial stone that was donated by the Calvi Family has been placed under the flag pole at town hall
- Cash Flow: 108% over goal for cash in and at 3% below expenditures for the month
- FEMA check arriving, \$51,000.00 which is larger than expected for the HWY Fund
- Ag& Markets has sent the municipal shelter inspection report and HVARS which passed with 100% and the Dog Control report was submitted October 3, 2022
- Cash Balances: General Fund: \$3,014,347.00 which includes the ARPA money and investments Highway Fund: \$541,256.00 Total: \$3.55 Million

Councilman Welsh mentioned there was a garbage truck fire in Town today that UVFD responded to. The contents needed to be dumped on the road to be extinguished. The highway department arrived to help clean it up quickly and safely and he thanked them for their assistance.

2023 Budget Presentation by Supervisor & Budget Officer, Supervisor Maas

Town Board Reports

Councilman McGivney- nothing at this time.

Councilman Welsh has been working on the 2023 budget with emphasis on the capital improvements.

Councilman Gusikoff stated the new shed has been relocated to the Recycling Center and started construction and prepared for the electrical work that needs to be done

Councilman Durland agreed that the 811 'dig safely' team has been called and are awaiting approval before the new flag pole can be placed.

Town Clerk

Town Clerk Casey spoke about the upcoming Rabies clinic offered by DC. Early voting will begin and BOE has a schedule of the locations and times available on their website. The J-Cap grant for the Justice Systems phones has been submitted and accepted.

Highway

Superintendent Kading reported the Highway Dept. is looking to fill a vacancy of 1 crew member. They have been shouldering roads with the material they created a few years ago which means minimal expense to the town. DCSW will hydoseed those areas next week, weather permitting. They are still in the process of repairing catch basins throughout the Town. They will speak about truck purchases next meeting when all the information has been received.

Public Comments-None

CAC Conservation Advisory Council

CAC member, Josh Redinger spoke about the upcoming star gazing event, October 22 at 6:30 PM and noted the vast array that can be seen from rural Union Vale. Reforestation, trees for Tymor, November 5th pushed back due to drought will replace 115 trees

lost in town, asking for donations for \$5 per tree or volunteers to assist in planting.

Parks Report

Jake Gosnell, Park Manager reported the GAA festival went very well the group was organized and he thanks them and the constables for keeping everyone safe. Fall prep and beginning the festival of lights. Shed was moved to the recycling center. The Highway Dept shouldered roads near Tymor park and graded areas that needed it.

Monthly Report for September 2022

Constables patrolled approximately 621 miles of town roads including all properties filling the Explorer with 23.4 gallons of gasoline.

The (3) town court dates totaled 25 cases on the dockets with 15 actual appearances and (5) cases were dismissed for failure to prosecute (officer failed to show for court). There were no issues to report. Constables had nothing to report during patrols this month.

Additional note: Constables provided security at the Hudson Valley Balloon Festival (9/2 - 9/4) and the October Festival (9/18) events held at Tymor Park. With large amounts of visitors at both events there were no major issues to report.

Animal Control, submitted by ACO, Mary Jean Calvi

September 2022, there was one lost dog, two found dogs and one wildlife call. (Due to confidentiality issues, additional information can be found in the Animal Control Officer's log book.)

Furnace Pond Dam

Supervisor Maas explained we are still waiting to do boring test, they have not called, one company that has the right size and engineers are trying to get us on the calendar.

Land Use Moratorium to Review Town Center Zone & Private Roads

Supervisor Maas noted they are to extend to the second extension that is built in, hopes the new town code revisions will be ready for review next week.

Playground at Godfrey Park

Supervisor Maas informed everyone they are waiting for 1 more design and residents will have 4 to choose from and share their thoughts with the Board.

Library Update – Trustees, MHLS

The Trustees have had their second meeting and are signed up for trustee training and have read their handbook. There is an open house Trustee reception on October 26 from 5:30-7:00 PM so that the community can meet them.

Replace Town Hall Flooring Project

Jake Gosnell, Park Manager spoke about the skim coat will be placed on floors before the material is placed to seal the concrete from any moisture. Mr. Gosnell did a moisture check and noted little to no levels for moisture and agrees that the skim coat will be sufficient without the need for an additional \$5,000 expenditure for a membrane.

Drainage Improvements – Hoofprint Road

Superintendent Kading has been working with Engineer, Tom Harvey for drainage improvements on Hoofprint and an analysis will be done this week and next week.

N. Clove Turning onto Rt. 82 – County Engineering Designs

DC has come up with designs in making that intersection safer. Residents from On The Green will review with the town as they will be utilizing it the most. There will be more information and a public hearing to help assist in choosing the best proposal.

Proposed purchase: New Commercial Grade Mower for Parks

Mr. Gosnell explained they have been using the same mower for 19 years but will soon need a replacement. Mr. Gosnell provided comparable machines and Brady's offered the state bid for a 52 inch will be an identical replacement and it will need a bagger system as well. The size is idea for the spaces they are mowing such as the pool and cemetery.

TOWN OF UNION VALE TOWN BOARD RESOLUTION No. 34-2022:

REGARDING A 90-DAY MORATORIUM EXTENSION

WHEREAS, by Local Law 2 of 2022, the Town Board of the Town of Union Vale ("Town Board") enacted a 90-day moratorium on the consideration of applications for and the issuance of approvals, variances, and permits for the uses currently allowed in the Town Center (TC) Zoning District, and for common driveway and private road permits in the Town, subject to certain exceptions and subject to extension; and

WHEREAS, the Town Board of the Town of Union Vale has commenced a comprehensive review of the Town of Union Vale Zoning Code as it relates to the Town Center Zoning District, and common driveways and private roads within the Town, and is currently working with the Town's consultants to consider possible amendments to the Zoning Code; and

WHEREAS, it is the Town Board's desire to complete its review of the Zoning Code, and the subsequent development, consideration, and ultimate adoption of any proposed zoning amendments in a deliberate and appropriate manner; and

WHEREAS, Section 6 of Local Law 2 of 2022 provides that the moratorium may, for good cause, be renewed, extended and modified by the Town Board of the Town of Union Vale for up to two (2) additional 90-day periods.

WHEREAS, the 90-day moratorium expired on October 4th, 2022, and it is anticipated that the Town Board will need additional time to complete this process, and accordingly the Town Board desires to extend the current moratorium for an additional 90-day period; and

WHEREAS, the Town Board determines that the extension of the moratorium is a Type II Action not subject to environmental review pursuant to 6 NYCRR §617.5(c)(36),

NOW, THEREFORE, BE IT RESOLVED that the recitations above set forth are incorporated in this resolution as if fully set forth and adopted herein; and

BE IT FURTHER RESOLVED, that the aforesaid moratorium be hereby extended through January 16th, 2023.
