NEW BUSINESS

Alderman Racey made a motion to Authorize and Approve the Omnibus Consent Agenda consisting of the July 7, 2021 council meeting minutes and the Warrant (\$22,523.12). Alderman Tuey seconded the motion. All in favor motion carried.

Alderman Pitts made a motion to Authorize and Approve Resolution 21-04, A Resolution Increasing the Established Fees for use of Park Shelters. Alderman Tuey seconded the motion. All in favor, Motion carried.

Alderman Racey made a motion to Authorize and Approve Resolution 21-05, A Resolution

Establishing Fees for of the City Amphitheater. Alderman Moore seconded the motion. All in favor, Motion carried.

Alderman Tuey made a motion to Authorize and Approve Resolution 21-06, A Resolution Requesting Temporary Closure of Streets for the Annual Fall Festival Parade October 2, 2021. Alderman Pitts seconded the motion. All in favor, Motion carried.

Alderman Racey made a motion to Authorize and Approve donation to the Johnson County Elks for \$500.00 (Community Funds) to assist with the Fall Festival Event. Alderman Tuey seconded the motion. The vote was as follows: Hill-absent, Moore-abstain (Elks Member), Owen-yes, Pitts-yes, Racey-yes, Tuey-yes. Motion carried.

Joseph Emery said the grand opening for the Art Gallery off the square, previously delayed due to Covid, is scheduled for Saturday, August 28th at noon.


ELECTED/APPOINTED OFFICIALS


