## Lakewood Forest Civic Association Meeting Minutes – March 7, 2023

The monthly meeting of the LFCA was called to order at 7:06 pm by president Jodi Cole. Other board members present were Lori Estepp, Scott Johnson, Jamie MacKeen, Mary Blacklock, and Linda Musthaler. The guests in attendance were Terri Cole and Chris Bacon.

#### Minutes

The minutes from the February 2023 meeting were reviewed. Minor changes were needed. Scott J. made a motion to accept the minutes pending the minor correction. Mary B. seconded the motion and it passed unanimously.

#### Treasurer Report

Scott J. provided the monthly financial reports for February. As of February 28, 2023, we had \$23,781.81 in total funds. There is \$8,700.58 in the checking account. The money market account has a balance of \$9,508.82 and the 12-month CD has a value of \$5,572.41. The CD has a maturity date of March 27, 2023. Scott J. will see if we can renew the CD with a higher interest rate.

We did not receive any memberships dues from the Fund this month. Scott will contact Graham Management to see what the holdup is. Jennifer Kozak, president of the Fund Board, did say we can get a list of the LFCA members.

We received a \$700 payment from the Fund to cover costs for National Night Out last February. We issued three checks in February totaling \$379.46.

Linda M. gave an update on the plans for this event . We have the pavilion at Russ Poppe Park for Sunday, March 26. The event will be held from 1 pm to 3 pm. Linda booked a bouncy house. The Fund has offered to provide refreshments. Garden Club will have a table to help kids plants flower seeds. A face painter has been booked.

#### 4th of July event

We voted last year to not have a parade event this year. Linda M. has started discussions with the LRC and the Fund about creating a new kind of event centered around the pool at the LRC. Planning will start in May.

#### **New Business**

The Fund has verbally agreed not to charge us \$1800 administrative fee next year. Nor will we have to do the financial review.
