ELIGIBILITY

We may be able to assist you if:

- California Convictions (Adult only)
- NOT on parole
- Served at least HALF of probation
- NOT currently charged with new offense

HOW TO PREPARE

- ✓ Bring Valid Photo ID
- ✓ Get Criminal Case Information
 - DOJ Rap Sheet - see back for Livescan instructions
 - Court / Case paperwork
 - Recent Background check
- ✓ Bring Proof of Post-Conviction Accomplishments:
 - Completed Court-ordered or voluntary programs
 - Letters of recommendation
- ✓ Receipts of payments for fines, fees or restitution:
 - Contact Office of Revenue & Recovery at (619-515-6200) for summary of monies owed

WHAT TO EXPECT

- Due to the different types and numbers of cases, participants may not be seen in the order of arrival.
- Be prepared to spend 2-4 hours at the Clinic as it will take time to review your eligibility, draft declaration, and prepare court forms. We are all volunteers and we appreciate your patience.
- Receiving assistance at the Clinic will often require more than one visit, depending on your record. Participants asked to return will be placed on priority list for the following Clinic.

NEED YOUR CRIMINAL HISTORY?

In order to receive services at the Clinic, you will need to provide information about your criminal cases.

If you do not have your case information, you may get your DOJ Rap Sheet by getting a Livescan on-site at the Clinic. Your DOJ Rap Sheet will show all of your adult convictions in the state of California.

The Clean Slate Clinic has partnered with Community Livescan Services to provide discounted fingerprinting services on-site at the Clinic and at Livescan Only events.

- ✓ **Valid Government-issued ID** - Expired IDs will NOT be accepted
- ✓ **\$25 DOJ Record Review Fee** - The DOJ charges \$25 for a copy of your Rap Sheet. You may qualify for a **DOJ Fee Waiver; you must provide proof of:**
 - **Government Assistance** (EBT card, Medi-Cal card, award letter for SSI, Social Security, Disability, or Unemployment)
 - **Low-Income Verification** (pay stub, tax return, letter from homeless shelter, transitional home)
- ✓ **\$15 Rolling Fee** - Community Livescan Services offers a reduced rolling fee for DOJ Record Review requests. Other fingerprinting services are offered at DOJ listed prices.

You should receive your Rap Sheet in 1-2 weeks. Call the DOJ at (916) 227-3835 with any questions.
