Peter S. Davis, as the court appointed Receiver, respectfully petitions the Court as follows: Peter S. Davis, as the court appointed Receiver, respectfully petitions the Court as follows:

1. On August 18, 2016, this Court entered its *Order Appointing Receiver*, which appointed Peter S. Davis as Receiver of DenSco Investment Corporation ("Receivership Order").

1 2. Pursuant to this Court's *Order Re: Petition No. 1*, the Court approved the
2 Receiver's compensation at the rate of \$250.00 per hour together with all reasonable costs and
3 expenses incurred relating to these services as Receiver. These services are billed by and paid
4 to the Receiver's firm, Simon Consulting, LLC.

5 3. Pursuant to this Court's *Order Re: Petition No. 1*, the Receiver has engaged the
6 services of the law firm of Guttilla Murphy Anderson, P.C., of Phoenix, Arizona, and the
7 Receiver has agreed to pay the law firm compensation at agreed hourly rates for the services
8 of the firm together with all reasonable costs and expenses incurred on behalf of the Receiver.

9 4. Pursuant to this Court's *Order Re: Petition No. 2*, the Receiver is authorized to
10 file this fee petition without including as exhibits the itemization of services rendered to, and
11 costs incurred or expended on behalf of, the Receivership, provided that the fee petition
12 includes a statement that anyone desiring additional information concerning the services and
13 costs to be paid under the fee petition may obtain redacted information from the Receiver by
14 delivering to the Receiver and the Receiver's counsel, Guttilla Murphy Anderson, P.C., a
15 written request specifying the additional information requested at least three (3) days prior to
16 the date set for any hearing on the fee petition. The *Order Re: Petition No. 2* further provides
17 that upon request of the Court, the Receiver shall make available for in camera review by the
18 Court the itemized statements and supporting documentation for the services and costs to be
19 paid under the fee petition. Pursuant to the Court's *Order Granting Motion for Signed Order*
20 *to File Under Seal Invoices to Receiver's Petition for Order Approving Fees and Costs*

1 *Incurred by the Receiver and his Attorneys* dated October 2, 2023, the Receiver has submitted
2 the itemized statements for “In Camera” review.

3 5. The Receiver has submitted an itemized statement for services rendered to this
4 Receivership by the Receiver and his firm, Simon Consulting, LLC, and for reimbursable costs
5 incurred or paid during the period of September 1, 2023, through September 30, 2023. The
6 total amount requested for payment by the Receiver is \$1,531.50. The Receiver believes that
7 this amount is reasonable and should be paid from the Receivership Assets.

8 6. The law firm of Guttilla Murphy Anderson, P.C., has submitted an itemized
9 statement for services rendered to this Receivership and for reimbursable costs incurred or
10 paid during the period from September 1, 2023, through September 30, 2023. The total amount
11 requested for payment by the law firm of Guttilla Murphy Anderson, P.C. is \$4,950.61. The
12 Receiver believes that this amount is reasonable and should be paid from the Receivership
13 Assets and has therefore approved this statement for payment.

14 WHEREFORE, the Receiver respectfully requests that the Court enter an order
15 authorizing the Receiver to pay from Receivership Assets:

16 1. The amount of \$1,531.50 to Simon Consulting, LLC, for services rendered and
17 costs incurred or paid during the period September 1, 2023, through September 30, 2023; and

18 The amount of \$4,950.61 to Guttilla Murphy Anderson, P.C., for services rendered and
19 costs incurred or paid during the period September 1, 2023, through September 30, 2023.
