## WEST VIRGINIA

West Virginia was carved from the State of Virginia during the Civil War, becoming a state in 1863, and was constituted as a single-district the following year.<sup>1</sup> The state was divided into the Northern and Southern Districts in 1901 with a separate judgeship authorized for each.<sup>2</sup>

WV.ND.01, the original judgeship (see Judge Dayton's succession line), was assigned to the Northern District when the state was split jurisdictionally in 1901.<sup>3</sup> WV.SD.02 was created as a temporary line in 1921,<sup>4</sup> with the proviso that the next vacancy to occur would not be filled. When Judge Keller died in office later that year, WV.SD.01 was discontinued and WV.SD.02 effectively became a permanent line. The courts were reorganized in 1983. WV.SD.05.01, authorized as a temporary slot, was transferred to the Northern District (WV.ND.03) and converted to permanent.<sup>5</sup> WV.SD.06, which was authorized in 1936 as a temporary judgeship to serve both districts, was converted to permanent in 1954<sup>6</sup> and in 1983 assigned exclusively to the Southern District.<sup>7</sup>

West Virginia is housed in the Fourth Circuit and has eight judgeships: three in the Northern District and five in the Southern.
