Notices & Agreements:

Hours: Performers must be onsite, in full garb and ready to perform by 9:30 AM each festival day for Performers Morning Meeting on Saturday and Cast Photo on Sunday. All performers must be available to perform rain or shine from 10:00 AM until 5:00 PM Saturday & Sunday; unless prior arrangements have been made with Festival Owners/Management.

### Rules & Policies:

Performers must appear throughout entire contract days in full garb; shoes are mandatory for all performers, street and stage. It is the responsibility of each contracted performer to provide his/her own garb and accessories necessary to perform contracted job.

All performers must be on time and perform as scheduled in the program unless otherwise specified by Festival Owners/Management.

All Weapons must be sheathed and peace bound at all times, with the exception that those stage shows that use weapons as part of their show and any lang scenarios that call for the use of weapons. It is expected that at the end of said shows, all weapons will either be peace bound or stored in restricted access area.

There is a strict zero tolerance for the consumption of alcohol on fair site at any time as well as the use and/or distribution of illegal substances at any time on fair site.

Violators will be turned over to the proper authorities for prosecution and all contract monies will be forfeited. Also, offenders will be banned permanently from any and all future involvement in Cowley County Renaissance Festival or activities related to Cowley County Renaissance Festival.

Performers must abide by all rules and policies of Cowley County Renaissance Festival. These rules and policies are incorporated herein and become part of this agreement between the performer(s) and the Festival.

This contract is terminable at will by Cowley County Renaissance Festival for violations of these rules and policies. Any violation of these rules and policies will result in forfeiture of all contract monies agreed to.

### Special Provisions:

Payment will be made at the close of Festival 13 April, if possible. If not possible, payment will be made within ten (10) business days after close of Festival.

If for any reason the Festival does not open on any scheduled day, the contract price shall

be adjusted on a pro-rated basis. If for any reason a performer does not perform at an agreed upon time and place, the contract shall be adjusted on a pro-rated basis.

The performer(s) agrees to allow Cowley County Renaissance Festival and its associates to use photos, video, and performer's individual likeness for advertising purposes of the Festival.

The undersigned agrees to indemnify Cowley County Renaissance Festival, its owners and managers, and hold the aforementioned parties harmless from any liability whatsoever from claim; including but not limited to bodily injury, property damage, fire, theft, explosion, or any loss sustained by the undersigned or any of the undersigned's group while contracted with Cowley County Renaissance Festival.

It is agreed that the above contractor is an independent contractor and as such is responsible for all and any taxes, including workman's compensation.

This contract is a confidential agreement with said performer(s); neither the contracted performer(s) nor Management of Cowley County Renaissance Festival shall disclose any of its compensatory details to any other party.
