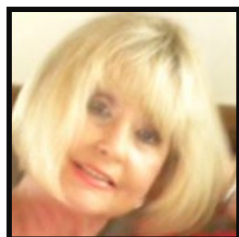

## NCRWF Campaign & Precinct Report

### 2018 INSTRUCTIONS FOR NEW GOTV PROGRAM



Republican Women along with the San Diego County Republican Party will soon be walking hundreds of precincts to Get Out the Vote. In the past we had printed walk sheets of names and addresses to guide us to the Republican voters. ***This year we will be using our smart phones to view these voter lists.***

The California Republican Party is using a program called Advantage Mobil to organize this year's walk. To download and install Advantage Mobil on your phone, you will go to either...

**the App store (I Phones) or to Google Play (Android phones)**

Your Area Leader will give you your User Name and Password and you will log in to the Advantage Mobil Walk Program to see your precinct. (When you signed up to walk, Connor assigned a precinct to you based on your home address. This precinct will appear on your phone when you sign in)

There are two ways to see the voter names and addresses on your phone...by Map or by List.

If you use the **LIST format**, it looks very much like the printed paper lists we have used in the past.

In your precinct, you will be able to see names and house numbers for Republicans living on each individual street. Your Area Leader will explain what you are to do with the voter information on your list.

It is very simple. You find out... Was the voter home? yes or no Does he plan to vote? yes or no

That is pretty much it. No survey...no long speech from you.

Ask for the voter by name, introduce yourself and say you are the Republican volunteer for this neighborhood.

*I'm here today to give you a copy of the Republican Voter Guide. This guide also includes Republicans running in Non-Partisan races in our County.*

Tell them for additional candidate information go to: [sandiegorepublicans.org](http://sandiegorepublicans.org)

Remind them: If they are voting by Absentee ballot, the ballot must be postmarked no later than **Election Day, June 5, 2018.**

If they are voting at the polls on Election Day, polls are open 7 am to 8 pm.

Remember! **The #1 goal of GOTV is to get a copy of the Republican Voter Guide into the hands of the Republican Voters and ask them to vote. That's It!**

#### WHAT IF YOU DO NOT HAVE A SMART PHONE?

You can team up with someone that does have a smartphone. The phone holder person tells you which house to visit, while she visits a different house on the block.

Afterward, the walker tells the phone person the results. Was the voter home? Did he say he would vote?

The Phone person inputs this information into her phone for each voter visited.

If you have extra people, You can have one phone person and two walkers. Each goes to his house and reports back. The phone person gives out the next two names to visit. Meanwhile he inputs the information given to him by the walkers and sends it on.

If you use this model...each walker should bring a small notepad and pencil to write down the assigned name and house numbers before the visit. Only one voter guide is left for each house even if multiple Republican voters live there.

#### WHAT IF YOU CAN'T WALK AT ALL???

The SD County Republican Party has a new phone program to reach Republican voters in inaccessible areas...where we can't walk like the top of a mountain. If you can help with the "Call-Out- the-Vote" project, please let me know or contact Connor Fallon - [connor@sandiegorepublican.org](mailto:connor@sandiegorepublican.org) 317-607- 2980

Remember...**all of these voters are Republicans and have voted in the last 5 elections for Republicans.** So why do we need to visit them you may ask? ...Maybe why they voted so consistently is because someone like you called them or came to their house and made a connection!

This election can be fabulous for us...if we get our voters to the polls.

Ed Rollins, 40 year political consultant, and frequently seen on the Lou Dobbs Fox Business Show always says:

**Winning elections isn't that hard- you only need to do three things!**

**1) identify your voters, 2) talk to them about what you want to accomplish, 3) get them to the polls.**

Step 1 is done by the local Republican Party

Step 2 is done by the candidates

Step 3 is done by **people like YOU!**

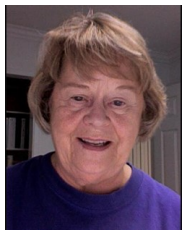

Recommendations for June ballot measures Source: CFRW Capitol Update

**Proposition 68:** NO California Parks, Environment, and Water Bond- would issue a \$4 billion general obligation bond, with a 3.5% interest rate over 30 years, bringing the bill to the taxpayers up to \$6.4 billion total.

**Proposition 69:** NO Transportation Taxes and Fees Lockbox and Appropriations Limit Exemption Amendment- states that Senate Bill 1 revenue from diesel taxes will be placed in a “lockbox” and used only for transportation fund purposes. Supported largely by contractors, unions, and the Democrat Party.-kd]

**Proposition 70:** NO Vote Requirement to Use Cap and Trade Funds Amendment- would require a one-time vote in 2024 by a 2/3rds legislative majority to allocate state Cap and Trade program revenue. [If legislators succeed at securing a two-thirds vote, revenue would begin to fill the non-reserve Greenhouse Gas Reduction Fund, which requires a simple majority vote to use the funds.—Ballotpedia.com]

**Proposition 71:** YES Effective Date of Ballot Measures Amendment- changes the date for when voter approved ballot measures take effect from the day after the election to the fifth day after the Secretary of State certifies the election.

**Proposition 72:** YES Rainwater Capture Systems Excluded from Property Tax Assessment-would exclude any new rainwater capture structures from property value tax reassessment from counting as a new structure.

### MAY 2018 LEGISLATION REPORT

#### CALIFORNIA

Some good news. SB 827, a homelessness bill which would have allowed increased density around local transit hubs, died in the Senate Transportation Committee April 18. Most local jurisdictions opposed it due to loss of local control and zoning. Source: [leginfo.legislatures.ca.gov](http://leginfo.legislatures.ca.gov).

More good news. State Sen. Pat Bates’ (R-Laguna Niguel) bill (SB 1109) on opioid education passed out of the Senate Business, Professions, and Economic Development Committee with bipartisan support. SB 1109 would educate the public, especially those who are involved with youth, by explaining to them the risk of addiction and overdose from prescription opioids. Co-author is Republican DA candidate Summer Stephan. Source: Sen. Bates’ April newsletter.

Last but not least in the good news column is the growing opposition to “sanctuary state/county/cities (SB 54 which, of course, is already law in California). Several city and county councils, including the San Diego County Board of Supervisors, have passed resolutions reflecting their opposition to sanctuary status. Contact your county supervisors and city council members to oppose sanctuary policies and to protect your community. Be sure to thank those officials who are supportive! The First Amendment in California

Oppose SB 1424, the Internet: social media: false information: strategic plan, basically fact-checking of Internet news stories. Currently in the Senate Judiciary Committee, this bill would place the government of the state of California in a position of arbiter of truth and would allow them to censor any information that runs counter to the official narrative. This is especially dangerous for activists and dissenters, or anyone who finds themselves questioning authority or exposing corruption. Source: [dcclinesline.com](http://dcclinesline.com)

The California “Resistance” in health care Democrats in Sacramento intend to institute universal health coverage in California regardless of immigration status or price tag. They hope now to accomplish this “piece-meal” rather than on comprehensive single-payer legislation which comes with a \$400 BILLION price tag. Bills that have been introduced so far:

SB 1108 – prohibits work requirements in Medi-Cal.

SB 910 – Short-term limited duration health insurance, would prohibit the sale in California of Republican-proposed low-cost short-term insurance policies.

AB 2799 – Increases percentage of premium that must go to patient care

AB 595 Health care service plans: mergers and acquisitions would impose greater state oversight of health care providers who want to merge.

The push for these types of bills is led by Health Access, a Health Consumer Advocacy Coalition consisting of “organized labor, consumers, immigrant advocates and groups such as Planned Parenthood.” See [health-access.org](http://health-access.org). The coalition advocates a state-only individual mandate, compelling people to buy health insurance. Another goal is to expand coverage to undocumented immigrants up to age 26 and the elderly. California already provides healthcare coverage for all children, 225,000 of whom are undocumented. Source: [CalMatters.com](http://CalMatters.com)

A review of CFRW's April 20 Capitol Update . . .

Oppose AB 2943: Makes it a fraud to offer help, information, or materials to adults questioning their gender or sexuality.

Oppose AB 1745: Bans ALL gas-powered vehicles by 2040. In Assembly Transportation Committee, sponsored by California Assemblyman Phil Ting, Bay Area Democrat. Interestingly, he has cancelled the budget hearing on this bill.

#### WASHINGTON

Major IRS reform is underway in DC, guided by the House Ways and Means Committee's Kevin Brady (R-TX). Per Brady, the reforms will be included in phase two of the Republican tax plan and will make the agency more taxpayer-oriented. He says a new and improved tax code requires a new and improved IRS. Source: federalradio.com

On April 18, the House Ways and Means Committee introduced § HR 5444, the Taxpayers First Act to establish an independent Office of Appeals, and § HR 5445, the 21st Century IRS Act to modernize IRS IT and cyber security.

Other bills to improve IRS services are to follow from the Committee.

And . . . President Trump has signed HR 1865, the Allow States and Victims to Fight ONLINE Sex Trafficking Act. This legislation, sponsored by Representatives Ann Wagner (MO-02) and Mimi Walters (CA-45), is the most significant anti-human trafficking legislation in years. Source: MajorityLeader.gov [Rep. As some of you know while we in Ireland last year a man broke into our home while we were asleep. Because of that, this past week, I was summoned to the Circuit Court, Tralee, County Kerry, Ireland to testify as a witness. I survived long flights, an early plane, lost luggage, long layovers to do my civic duty (though in another country). I learned a lot about the judicial system over there. Some similar things to ours, some different (i.e.: powdered wigs!). How trials are set up & juries are chosen.

The one thing that stood out through this whole experience is how we perceive our surroundings & people. While Rick & I both felt that the man was perhaps mildly mentally challenged but completely harmless; this man had an extreme criminal history. The reality was he wasn't completely harmless & was really a threat to us & others. An adrenaline rush played into the scenario & allowed us to think of the incident as "not a big deal". We found that when all is sorted out, we perceived the man as confused, he had an agenda.

God gives us the ability to have the perception of a situation, to weigh the pros & cons, even in a quick-thinking scenario. God allows us to take control for our safety or let others with better knowledge to do that. He grants us the free will to know which side to pick in that instant. How do we choose that which surrounds us? How do we react to the situation? Do we go for the quick reaction? Or the reflection first? Do we go for the suspicious first or the caring side first? Do we let God make our split-second decisions? How do we perceive the world around us? Better yet, do we really see what is around us, or is it a reality that we make up so that we don't have to face the reality?
