

## The Bounce Palace, LLC Rules for Renting our Inflatables

We want you to have a fun time with our inflatables however not at the expense of our equipment. We have to keep our equipment clean and safe. We ask our customers to be respectful of our equipment while it is in your possession. Please initial beside each rule and sign at the bottom.

### Initial

\_\_\_\_\_ **DO NOT** under any circumstances move any Bounce Palace equipment (including but not limited to inflatable unit, tarp, stakes, sand bags, blowers, extension cords) unless approved or requested by a Bounce Palace representative.

\_\_\_\_\_ Sharp objects **ARE NOT ALLOWED** on or around our units. We strongly suggest NOT wearing Jeans with metal decorations on the pockets, eye glasses, jewelry, etc. as they tend to scar, cut, &/or damage our inflatables. If our units are damaged there will be an additional damage/replacement charge.

\_\_\_\_\_ The Bounce Palace, LLC **CANNOT AND WILL NOT** set up on PET WASTE of any kind! Please ensure your yard is free of all pet waste prior to delivery. There is a special cleaning process required for waste and will result in additional charges.

\_\_\_\_\_ Pets are **ABSOLUTELY NOT** allowed on our units at any time. Pets should be kept up after our equipment has been delivered and set up. There will be a special cleaning fee if there is any sign of pets being on our equipment, including but not limited to feces, pee, hair. This will result in an additional cleaning charge. Pets can also cause damage if they are on or around our equipment, including but not limited to claw marks, chewing, scratching. This will result in an additional damage/replacement charge.

\_\_\_\_\_ If you plan to mow, please mow/weed-eat 3-7 days prior to delivery. **DO NOT** mow/weed-eat the day of delivery. **DO NOT** mow/weed-eat after our equipment has been set up. This can cause damage or excessive dirt build up on our units. This will result in an additional cleaning and/or damage/replacement charge.

\_\_\_\_\_ Any type of lubricant (i.e. soap, oil of any kind, etc.) is **ABSOLUTELY NOT** allowed. These can deteriorate the seams or damage the vinyl of our equipment. There is a special cleaning process required for this and/or possible repairs and will result in an additional charge. The use of these items can also cause injury to the participant as it can cause them to go over the end of our slides onto the ground.

\_\_\_\_\_ There are to be **NO** open flames (i.e. camp/fire pit fires, bon fires, etc.), fireworks, or any other type of flammable objects near our equipment. Floating embers, excessive heat, or flames can cause damage to our equipment and can result in damage/replacement charges.

\_\_\_\_\_ Food/drinks **ARE NOT ALLOWED** in or near our equipment, including cotton candy machines due to floating sugar that attaches itself to our units and requires a special cleaning process.) This will result in additional cleaning charges.

\_\_\_\_\_ Silly string and/or pinatas **ARE NOT ALLOWED** on or near our equipment. Silly String can cause damage and cause fading to the vinyl and the colored paper from the pinatas will stain the vinyl. This will result in additional damage charges.

\_\_\_\_\_ The use of any tubes, air mattresses, or other "ride-on" items are **PROHIBITED** as these can cause injury to the participant by causing them to go over the end of our slides onto the ground.

Additional cleaning fees can range anywhere from **\$50-\$2,000** depending on unit and extent of filth. We expect the units to be dirty (i.e. dirt, grass, dust, hair, etc.) after use and this is normal and you will not be charged for this. Charges arise from extreme filth (i.e. full of mud, pet hair, pet waste, food, or other items listed above).

Additional damage fees can range anywhere from **\$50-\$10,000** depending on unit damaged and extent of damage. There is a possibility that the unit will have to be replaced if it cannot be repaired.

**The customer is responsible for any and all cleaning, damage, and/or replacement fees caused from misuse of the equipment as outlined above. Including possible loss of income due to timing of repairs/replacements.**
