There being a quorum, Mayor Owen called the meeting of the Vienna City Council to order at 6:30 p.m.

NEW BUSINESS

Alderman Tuey made a motion to Authorize and Approve the Omnibus Consent Agenda consisting of the December 7, 2022 council meeting minutes, December 7, 2022 public hearing minutes, the Warrant (\$23,501.86), and the November Treasurer's Report. Alderman Hill seconded the motion. All present in favor, motion carried.

Brian Ziegler, Clarida & Ziegler was present to discuss a transfer of contract of recent agreement with council. Alderman Moore made a motion to Authorize and Approve a transfer of contract, "Redbud Lane Road Overlay and Industrial Park Entrance" from Clarida & Ziegler Engineering Co. (CZE) to Horner & Shifrin, Inc. (H&S). Alderman Hill seconded the motion. All present in favor, motion carried.

Wright noted the proposed amount on agenda item #6 included tax, correcting the proposed amount to \$2,580.00. Alderman Racey made a motion to Authorize and Approve quote to purchase awnings for the city library from Parker's Canvas Product, \$2,580.00 (General Funds). Alderman Tuey seconded the motion.
