

ORDINANCE 391

AN ORDINANCE AMENDING ORDINANCE 390. AN ORDINANCE RELATING TO THE USE OF THE STREETS AND PUBLIC WAYS BY THE CITY OF GAYLORD, KANSAS, superseding all other ordinances providing for the utility services passed prior to February 9th, 2022.

Be it ordained by the governing body of the City of Gaylord, Kansas:

SECTION 1. Every person or operator in charge of a motor vehicle shall, when parking any such vehicle, park or stand the same at the curb along the side of the roadway or traveled portion of the street, headed in the direction of traffic and with the right-hand wheels of said vehicle standing within twelve (12) inches of such curb, or where there is no curb, then the left-handed wheels of said vehicle shall not be closer than two feet from the graveled portion of the street: Provided, that within the blocks along Main Street, between 5th and 7th street, all vehicles shall be parked at any angle of approximately forty-five (45) degrees to the curb with the right front wheel thereof touching the curb and within the lines on curb or on the street indicating such angle parking spaces and provided further that no non-motorized vehicle, ag related equipment, trailer, or semi-trailer shall at any time be parked on Main Street between 1st through 9th Streets.

SECTION 2. It shall be unlawful for any person or persons to store, stand, or allow to remain in or on any street, alley, parking sidewalk or public way in the city, any dead, damaged or disabled automobile or vehicle of any kind, or part thereof or any junk broken down, or abandoned vehicle or machinery of any kind, or merchandise of any kind. It shall be the duty of the owner or person responsible for any of the above vehicles, machinery, junk, or merchandise, to remove the same from the place where it may be found after notice from the city marshal or public officer: Provided that the city may cause the said Marshall, Public Officer or Commissioner of the city to remove all such described vehicles, machinery, junk and merchandise, to a place designated by the city at the time of occurrence, the same shall not be deemed to relieve the owner or responsible person from any penalty of this ordinance.

SECTION 3. All ordinances or parts of ordinances contravening to the provisions of this ordinance are repealed.


SECTION 4. Any person upon conviction of the violation of any provision of the ordinance shall be punished by a daily fine of not less than \$25.00 and not more than \$250.00.

SECTION 5. This ordinance shall take effect and be in force from and after its publication in the official paper. Passed this 9th day of February, 2022.
