



Valentine Red print, pink







Pink: A: Cut two 6 7/8; cut in half diagonally

B: Cut eight 2 5/8

Red: C: cut eight 2 5/8

Sew two rows together: B+C+B+C; Sew two rows together: C+B+C+B Sew rows together as in diagram to make square. Then sew A pieces onto four sides as in diagram.


#### KING RANCH CHICKEN


Makes 6 to 8 servings

Think of this cosserole as a south-of-the-border-inspired lasagna with layers of hearty chicken and veggies, a creamy sauce, sturdy tortillas, and plenty of cheese.

- 2 tablespoons unsalted butter
- cup chopped onion
- cup chopped red bell pepper
- 2 cloves garlic, minced
- 2 teaspoons chili powder
- 1/2 teaspoon ground coriander
- (10%-ounce) can cream of celery soup
- (10%-ounce) can cream of chicken soup
- 14 cup chicken broth
- rotisserie chicken, meat shredded, skin and bones discarded (about 3½ cups)
- (10-ounce) can diced tomatoes with green chiles, drained
- (4-ounce) can diced green chiles, drained
- 1% cups shredded sharp Cheddar cheese, divided
- 10 corn tortillas, cut into quarters
- Chopped tomato, chopped green onion, and pickled jalapeño slices, to serve

- Preheat oven to 350°.
- 2. In a 12-inch cast-iron skillet, melt 2 tablespoons butter over medium-high host. Add onion and bell pepper; cook, stirring occasionally, until vegetables are soft, about 8 minutes. Stir in garlic, chili powder, and coriender; gook for 1 minute. Transfer vegetables to a large bowl, and let cool. Wipe skillet clean; spray with cooking spray.
- 3. Stir soups and broth into vegetables; stir in chicken, tomatoes, and chiles until well combined.
- Spread one-third of chicken mixture in bottom of skillet. Sprinkla with 1/2 cup cheese. Top with a single layer of 20 tortilla wedges, overlapping as needed to fit. Repeat layers once. Spread remaining chicken mixture onto tortillas; sprinkle with remaining 1/2 cup cheese.
