Anu Sharma, Au.D.

Anu Sharma Ph.D. is Professor and Associate Chair in the Department of Speech Language and Hearing Science and Fellow in the Institute for Cognitive Science and in the Center for Neuroscience at University of Colorado, Boulder. Her research examines neuroplasticity in children and adults with hearing loss who receive treatment with hearing aids and/or cochlear implants. Her research has been funded by the United States National Institutes of Health for over two decades. She is fortunate to have given over 200 invited presentations and keynotes spanning six continents. She has given the Carhart Memorial Lecture at the American Auditory Society, the Marion Downs Lecture twice at the American Academy of Audiology and the Ted Evans Lecture at the British Society of Audiology.



John DeWorken

John Deworken has 20 years of experience working in and around the SC State House. He served as a legislative director for the SC Senate and held senior positions at the SC Chamber of Commerce, the Greenville Chamber and on a statewide political campaign. Strader, AuD serves as the Executive Director of the Institute for Cochlear Implant Training, creating professional education experiences for Audiologists, Surgeons, and Interventionists who specialize in cochlear implant care. She received her Bachelor of Science from Purdue University and her Doctorate of Audiology from Wayne State University in Detroit, MI. She completed her fellowship with the University of North Carolina Pediatric Cochlear Implant Team and previously worked with the St. Louis Children's Hospital Pediatric Cochlear Implant Team, where she grew her passion for clinical education and training. She is currently a CI Audiologist for the Prisma Healthcare cochlear implant team, a growing CI team in the Upstate of South Carolina. She recently helped to lead a consensus team to revise the Minimum Speech Test Battery (MSTB-3) to guide adult cochlear implant care.



Rita Chaiken, Au.D.

Dr. Rita Chaiken has been a private practitioner in Atlanta, GA, and an Adjunct Professor of Audiology at Salus University as well as past president of the Academy of Doctors of Audiology.
