Your submissions will not be juried until your jury fee payment is received. Jury fees are not refundable for any reason.

You will be notified by e-mail as to the jurors' decision within one week after all materials have been received. If accepted, you will be emailed a registration form.

Your registration form and site fee payment of \$110 (\$100 members) should be <u>received</u> no later than May 15th to confirm your participation and to be included on all promotional materials. Late returns may be accepted if room allows, but your name will not appear on any promotional materials (postcards, posters, press releases, and ads). PLEASE NOTE: Site fee is non---refundable after May 15th for any reason.

If you wish to become a 2018 member of the *Center for the Arts* at that time, please make a payment of \$125 for both registration and 2018 membership.
