

Asotin County Fire District 1

Thank you for the opportunity to serve our community. Asotin County Fire District 1 provides emergency response services to 14,000 people. We are the only fire district in the county to guarantee a fire and EMS response 24-hours a day. Thirty-two volunteer firefighters, 28 emergency medical technicians (EMTs)—some EMTs are also firefighters—and 35 paramedics are proud to respond to an average of 2,600 calls per year – 90% of which are EMS-related.

Emergency Medical Service

EMS calls have increased almost 38% since voters approved funding for the program in 2011. Our EMS levy provides Basic Life Support with firefighter/EMTs and Advanced Life Support with paramedics through our partnership with the city of Lewiston.

History

- 1950 Population in Asotin County grows 30% in 10 years.
- 1951 Asotin County Fire District 1 formed by a vote of the people to serve the greater Clarkston area outside the city limits.
- 1952 Purchased first two fire trucks for use by 15 volunteer firefighters.
- 1980 Population grows 22% in 10 years. Hired fire chief as first full-time employee.
- 2000 Population increases almost 17% in 10 years.
- 2003 Hired an assistant chief, the fire district's second full-time employee.
- 2006 Fire insurance rating improves, reducing insurance premiums for homeowners.
- 2009 Paramedics begin responding to emergency medical calls from the fire station through the Lewiston partnership. Response times are reduced. Call volumes increase from 260 to 1,800.
- 2010 Annexed 12 square miles south of Asotin. Started providing administrative services to City of Asotin Fire Department.
- 2011 Passed a 6-year levy for emergency medical service to maintain Advanced Life Support and pre-hospital care.
- 2014 Purchased building at 2377 Appleside Boulevard for future fire station.
- 2016 EMS levy up for renewal in August before it expires.

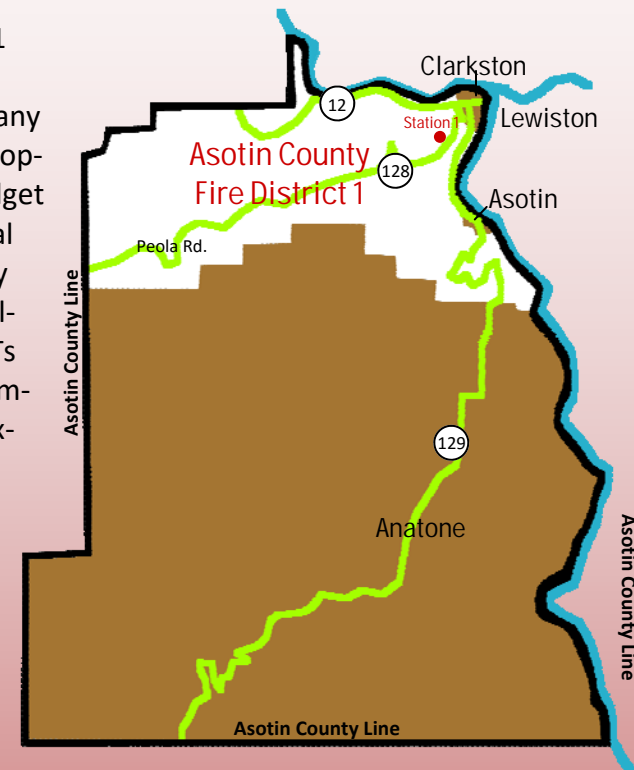

Asotin County Fire District 1 has the lowest levy rate for fire protection and EMS of any provider in the county. We operate under a balanced budget and have passed all financial and accountability audits by the state. Our dedicated volunteer firefighters and EMTs donate their time to the community, which saves our taxpayers approximately \$1,000,000 annually.
