- a. Friedrichs vs. CTA- Current lawsuit being decided, dealing with dues payed. Union is required to negotiate on behalf of all even if they don't pay dues.
- b. Possible effects:
 - 1. People could opt out; Not have payroll deduction, and may have to sign up each person as a member
 - 2. without 50% we will lose our bargaining rights
 - 3. could impact ability to negotiate health care

- 4. teachers might have to pay fifty % into retirement
- 5. relay the message to members of the importance of understanding what is going on and how it impacts us. Suggested- play video at the meeting- link in the newsletter-

ALSO Vote no on opening up state constitution- will destroy our pension.
