Colonial Acres Phase V Meeting Minutes 6.10.2020 VIA GO TO MEETING

Call to order Call to order at 3:02 pm the regular Board meeting of Colonial Acres Phase V, Inc. II. Roll call In attendance, Bill Charles, Judy Keeling, John McGraw, George Birchmeier – Jim Reuschlein and Stacy Klabak from Clearview Due to technical difficulties Cindy Christenson transmission was intermitted. Recording to be sent for review by email link.

Approval of minutes from last meeting Move to approve May minutes: Motion Judy, second by George. – Approved .

Financial Report for prior month – Jim Reuschlein a) Financial report – month ending May 2020 (i) Land Lease increase came through but was budgeted. Legal on two members will proceed in the following week. Paul’s Plumbing had reduced extra services due to the COVID lock down. Billing for May was \$1,226.16. **Bill Charles motion to approve** 1st John, 2nd George - Approved

VManagement Report – Jim Reuschlein, Clearview Property Management Services a) We have two units for sale currently. \$103,000 & \$112,900. Power Washing of siding was completed on 6/9/2020. Must come back to 101 because they ran out of time. We will need a more aggressive plan moving forward with additional siding being installed. Anticipate a \$5 -6 thousand cost. We do 6 buildings a year. The northern exposure buildings get the most need, but it makes a nice difference in the appearance. **George:** The power washing should go onto the forecast we worked on. Jim agreed. Vinyl work has resumed. John & Jim met with contractor and went over punch list that needs to be completed in the next couple of days.

Discussion on concerns from members. Judy, 56-4 has called about damage on her vinyl that has not been completed yet. Replacement where rail was. **Jim:** The member changed the rail position which left siding damage. But Jim told her we would take care of it. Jim will reach out to him (Adam) about getting her taken care of. Weather permitting. Contractor to have a better handle on workers and timeline.

Asphalt: Scheduled with contractor from last year on Tuesday 6/16/20 to walk and work through what the scope could be this year with the \$50,000 budget for 2020. **Judy:** Are you concerned with the quality of work and the cracks that are showing up. **Jim:** The items that show issues are a result of prior years of fixes to try to extend the life of the roads. Jeff with the Asphalt will also get us some numbers on concrete to have some choices. **Bill;** have him look at Heritage north of clubhouse while he is out. **Jim:** we may want to bump the amount we spend since we have some savings in the budget with the closedown. Will get you the numbers. **Tax Tribunal** has yet to begin scheduling any hearing dates. **Paul Traila** has not submitted a new contract to date. Jim to get with him and give him 2 weeks to provide a copy to the Board of Directors for review. **Judy:** Sprinklers need attention on 11-mile rd. to maintain new planting. Jim R will talk to Paul about where we are at in getting them up and running. **Bill**, our building was done a week ago. **John,**

Paul is having some issues getting into people’s homes. **Judy**, we are carrying water to the garden on Arlington Circle. **Motion to approve** 1st by John, 2 nd by Judy - APPROVED

Old business Comcast/Wow Both claim they are not putting any flags up in the community, it has been suggested it is ATT doing possible upgrades. Comcast will be looking for answers or approval soon on installation in CAV. Feedback was not received well in the property. Low response and minimal interest. Letters/survey were sent but we may need to re-issue a letter to each home to get more solid results. Comcast has offered an incentive to the property on a per home basis and it would start to bring the property into some of the fast-moving technology that seems to keep changing. The interest depends on if all 5 phases are involved. **Bill** asked that everyone think about it and weight the options and be prepared to discuss again. **Pool:** On 6/11/2020 Roman's Pools will be servicing the pool and maintaining the water. Judy, John, Doug (pool backup) and Mike will be present. **Judy**, Mike has stepped down and John Schornburg will be taking over as primary on the pool. He will also be in attendance to get instructions on the 11th. **Bill:** Katy wants out also due to desire to travel. She will be in attendance for the 11th also. **Jim & Judy:** Members are calling about the opening of the pool. Discussed Oakland County's recommendations and changes on pools. Stacy to forward Bill the documents and signs that would need to be reviewed for use. **Stacy:** Shared what guidelines we are following at other communities. Pools are to be used at half company or less and must have 6' distancing ability on or in pool area – recommends limit to 20 persons. Due to this limit of 20, CAV will not be able to allow guest access for this season. County has also indicated no more than 10 people can gather on a deck or area that has limited use and spread. Enclosed areas are the focal point on the limit. Pools cannot be opened until inspected and as of 6/10/2020 they are taking appoints to try to handle the backlog since they were closed. **Discussion on liability,** risks and the pros of health benefits to get outside. Majority is in favor of keeping facilities closed to side with the safety factor. **John:** We must get the procedures in place to follow CDC reporting to health department if we encounter a confirmed case. Pools cannot be opened until inspected and as of 6/10/2020 they are taking appoints to try to handle the backlog since they were closed. **Library Opening:** Members want to use How do we keep clubhouse and library sanitized? **Judy:** we can keep sanitizer out and place signs throughout. **George:** what do you do in a library, touch he books. How do we keep them safe for the next person? **Bill:** how do you sanitize a book? **George:** we could have a return box that we would have to quarantine for two weeks. **John:** It will not live on the books that long. **Judy:** I have seen people go in and use it. **George:** It is a tough call, how do you return it or just keep until COVID is done. **John:** The pool will need access to bathrooms to get in, how do we limit the other areas? **Bill:** We can block off the kitchen and clubhouse/library area. CDC still has it restricted to 10 - **John:** yes, the discussion continued with concerns too high to open any areas of the common areas.

New business Pool Staffing & Payments: **Judy:** Are we increasing pay per day to accommodate taxes being taken out? **Bill/Jim:** Pool workers are contractors and not on payroll system. They will be 1099 each year if they are paid over \$600 in a calendar year. Stacy to send to board sub-contractor forms for any persons doing any work at the community that is not covered by insurance or a business. Pay per day will remain the same. Judy will collect the hours/days every 2 weeks to approve and submit to Jim via email on the Monday of that week to ensure a check is cut on

Wednesday of same week. **Vinyl buildings:** **Bill:** Where are we at and what are we looking to finish this year. **JR:** 75-76-77 are finishing up and we expect to be through building 82 this year.

Sex Offenders? It has been reported that a possible registered Sex Offender lives in the community **Cindy** expressed concerns and with Georges help it was confirmed. **Bill:** This would not be the first time and what exactly do you think we can do about it? Building and unit withheld for liability reasons. Members are free to search online themselves if they desire. **Newsletter & published phone numbers:** Complaints about numbers placed in newsletter and members do not wish this to included. Newsletters are available online and are mailed to businesses that advertise in the newsletter. **Bill:** Asked John to not include moving forward. **John:** I do not perform that task so I will talk to Gloria about removing any numbers before publication. Directories are still our main source of membership contact and is limited to the membership. **Clubhouse & Pool:** **Jim** to see about new Rules sign being made. Rules were approved last month. New regulations will prevent the use of showers, drinking fountain and limit bathrooms to no more than 2 persons at a time. **Judy:** will cover/wrap fountain for no use thus eliminating the need to shut water on and off when hose is used. Hand sanitizer would be available but who would police the use and maintain the person limit? **Bill:** Our community is a high-risk population, so we need to consider the use of clubhouse and library. **John:** We have the camera's **Judy,** they would have to pay for the extra cleaning that would have to be done or they would have to do and we would have to see the camera to make sure it was done. **John & George:** The card players – 6' apart and not being able to pass cards back and forth or they all bring their own cards. Just will not work. **Bill:** who is going to sit and watch them and then what do you do. We also need the bathrooms cleaned often and remain open. Contractors need to have access for clear reasons. Can you (Judy) schedule to have bathrooms cleaned each week maybe twice a week. **George:** we need to flush the toilet so the traps can be moving, we also need a new wax ring in the men's room. **Jim** to have Paul do the wax ring.

Annual Meeting/Elections July newsletter should have election information. 3 people will have terms up. **Bill** to write an article for newsletter **Jim:** Advice of attorney on another job was possible postponement due to COVID and group size limitations. Add to June 24th meeting and **Jim** to hold on nomination form. **Bill:** Do we have support if we need to postpone Annual to Sept? **George, John & Judy** – yes. **Cindy** was not available..

Correspondence Board Member Reports **Judy,** what do I tell people who want to reserve the clubhouse or deck? **Bill,** we cannot allow more than 10 people and we have not made any decision on opening to members only till our next meeting on the 24th. The answer is no, we are not allowing any use or reservations currently. **Judy:** we have geese everywhere **Jim,** with the COVID we were unable to exercise the use of the program to curve any new hatching. Go To Meeting scheduled for June 24, 2020 at 3pm Re-visit COVID-19 status and options for clubhouse and pool. Discuss election options **Adjournment** **Bill** adjourned the meeting at 4:31 pm. July is here, and hair salons and barbershops are open. Restaurants can now serve you at a table instead of handing over your dinner in a carry out bag. I’ve gotten together with some friends at a park, where we all brought our own chairs, food and refreshments and sat in a large circle, each of us at least six feet apart, the first time we had seen each other in months.

Some of my friends are getting their haircut at salons and eating in restaurants. I’m not ready for that yet. I was surprised other day when a good friend, who had recently lost her mother, told me that ever since her mother’s funeral, she’s decided it’s okay to hug friends. When I suggested we meet, she said she’d love going out to a restaurant. I’m glad I spoke with her prior to our visit, so I could explain that I’m being much more cautious than her. I’m fine with ordering food, picking it up, and eating at her home while we keep a safe distance apart.

I didn’t expect to be navigating through social interactions with friends, as I assumed they all felt the same way that I do. I bet you also are encountering people who feel differently, regardless of how you are dealing with this virus.

This month, I spoke with three Colonial Acres Phase V residents, and found their behavior is pretty on par with mine. Wear a mask, keep social distancing, and be cautious.

John McGraw admits that he’s getting tired of all this, but he’s dealing with it. “I wish they had done more early on, because we are still dragging on with this. But, we have to do what we have to do. I’m following the Governor’s orders as close as I can.” John admits he’s cut his hair a couple of times, wears a mask to go grocery shopping, and shopped online at Best Buy with curbside pickup. He has not eaten at a restaurant yet but would consider it if wasn’t crowded. He thinks that cities like Plymouth, Northville and Brighton, that have closed some of their streets so restaurants can offer outdoor seating, are dealing with this well. “I think most people are afraid to go out just yet. Time will tell, I’m going to wait a while, maybe two weeks.”

He’s been getting together occasionally with friends, with each household sitting six to eight feet apart. Everyone brings their own refreshments, and they do not share food. When going out, he says he wears a mask, and if people come to too close, he puts his hand out to let them know to not come any further. He’s been golfing; everyone gets their own cart, which, he adds, works “pretty good. I love getting outside and getting away from everything.”

Heidi Strecker also dons her mask and gloves before shopping for groceries. She says that people are always friendly everywhere. “If someone is in the aisle I want to go down, I just wait for them to pass.” Heidi talks regularly to friends on the phone, but hasn’t visited anyone in person. “I’ve planted a lot of flowers; I keep busy giving them water. I walk every day, and you can see me out there with my stick walking around.” Will she go to the pool when it opens? “I think so. The exercise will do me good.”

Peggy and Tom Booker were blessed with two new great-grandkids during the pandemic. “If anything good came out of this, it’s my two great-grands,” says Peggy. Although she’s thrilled that they were born, she’s anxiously waiting to hold them someday. Haircut? Yes, please, for her dog, Corinna, before Peggy’s hair is trimmed. “It’s definitely more important for the dog to get her hair cut. I can’t see her eyes.” She’s started a jigsaw puzzle, which is still on the table. She’s made about 30 or 40 masks for her daughter, who works in the medical field. Peggy, like John and Heidi, always wears a mask when shopping. “I do love gardening. I have tomatoes, cucumber and green pepper plants growing in my little garden.” Peggy is

looking forward to going back to work as the “lunch lady” at Millennial Middle School. “My last day of school was March 15. I just love the kids. It will be interesting to see the changes in the lunchroom. It’s crazy stuff we are going through, but stay positive and be careful. We going to get through this.”

Good words to note. We’ll get through this.

Ticks and Skeeters

Two of my least favorite insects, ticks & mosquitos, seem to be out in great numbers this year. The Oakland County Health Division reminds us to protect ourselves against these bugs as we spend more time outside.

Reduce your risk for ticks by:

- Wearing long-sleeved shirts; light-colored, long pants; and closed-toed shoes.
- Tucking shirts into pants and pants into socks.
- Applying insect repellent containing DEET (20% - 30%) or Picaridin to exposed skin and to clothing.
- Applying permethrin to clothes and shoes (do not apply permethrin to skin).
- Avoiding contact with overgrown grass, brush and leaf litter.
- Protecting your pets as well, as they can come into contact with ticks and carry them into your home.

Check your entire body for ticks immediately after leaving outdoor areas likely to have ticks, and take a hot shower as soon as possible. If you discover a tick attached to your skin:

- Grasp the tick with tweezers as close to the skin as possible.
- Pull gently but firmly, but do not squeeze the body of the tick.
- Try to pull the tick out without leaving mouth parts embedded in the skin.
- After removing the tick, wash hands and bite area thoroughly with soap and running water.
- Apply an antibacterial cream to the site of the bite.

Follow these tips to protect you and your family from mosquito bites:

- Get rid of mosquito breeding sites by removing standing water around your home. Turn over any type of container that can collect water. Once a week, empty out items that hold water such as buckets, planters, birdbaths, pet bowls, flowerpots and trash containers. Clean clogged roof gutters, particularly if leaves tend to plug up the drains.
- Use Environmental Protection Agency (EPA)-registered insect repellent. All EPA-registered insect repellents are evaluated for safety and effectiveness, and will contain DEET, picaridin, IR3535, Oil of Lemon Eucalyptus or para-menthane-diol as the active ingredient. Repellents containing a higher percentage of the active ingredient typically provide longer-lasting protection. Always follow the product label instructions.
- Wear protective clothing such as long-sleeved shirts and pants.
- Avoid outdoor activities when mosquitoes are most active, especially late afternoon, dusk to dawn, and early morning.
- Maintain window & door screens to keep mosquitoes out of homes & buildings. Do not prop open doors.

From Your Board President:

I never imagined these times we now find ourselves living in. But COVID19 seems it will be affecting all our operations of Colonial Acres Phase V for the remainder of 2020. In this newsletter you will find minutes from our Board conference call meeting for June 2020. However, as in life, everything is in motion and subject to change as we work through what is best for our members.

We are working on ways to safely our open the pool and clubhouse. Your Board of Directors is concerned that we have no way of monitoring compliance with established rules and temporary rules in the operation of the clubhouse and pool. We may open the pool but restrict use of the clubhouse. We are working on the pool in making it operational just in case we are satisfied it can be opened safely. Due to health reasons our current pool manager has resigned. We are working on recruiting and training a temporary replacement. We are looking for a full-time pool attendant/manager. Anyone interested in this paid position is asked to contact the clubhouse chairperson or the President of the Board of Directors. If, or when, the pool is opened it will be restricted to members only for **2020, NO GUESTS**. This temporary rule will be strictly enforced.

We are working through these issues and will continue to have regular dialog. The best way to keep informed is the CA Phase V web site. We will endeavor to keep the information current on the web site. Also, we will post any changes on the entry door to the clubhouse.

Board has also had a lengthy and ongoing discussion about our annual meeting scheduled in September. Since attendance will be restricted the Board has decided to cancel the annual meeting. However, the Board also feels that we need to go forward with the election of of your Board members. There are three Board positions up for election. The Board has decided that we will conduct the election in September or October by mail in ballots.

Since we will conduct a mail in election for the three board positions in September or October. We request that any interested member submit your biography to me and Clearview Management for inclusion in the August newsletter. **The deadline for submission will be no later than 12 July 2020.** The email address for sending these bios are wcharles@ameritech.net and office@clearviewmi.com

FUN FACTS ABOUT THE FOURTH OF JULY

With 245 years of tradition behind it, the Fourth of July is one of America's most cherished holidays. It's when we celebrate our nation's mythology with a day off, a backyard barbecue, and plenty of fireworks. But with all that history, you may not know quite everything about July 4. So from the true story behind the signing of the Declaration of Independence, to some staggering hot dog statistics, here are a few things you might not know about the Fourth of July.

THE DECLARATION OF INDEPENDENCE WASN'T SIGNED ON JULY 4 It's now generally accepted that the Declaration of Independence wasn't signed on the Fourth of July—that's just the day the document was formally dated, finalized, and adopted by the Continental Congress, which had officially voted for independence on July 2 (the day John Adams thought we should celebrate). So, if you want to sound like a history buff at your family's barbecue this year, point out that we're celebrating the **adoption** of the Declaration, not the signing of it.

MASSACHUSETTS WAS THE FIRST STATE TO RECOGNIZE THE HOLIDAY. Massachusetts recognized the Fourth of July as an official holiday on July 3, 1781, making it the first state to do so. It wasn't until June 28, 1870 that Congress decided to start designating federal holidays, with the first four being New Year's Day, Independence Day, Thanksgiving, and Christmas. This decreed that those days were holidays for federal employees. However, there was a distinction. The Fourth was a holiday "within the District of Columbia" only. It would take years of new legislation to expand the holiday to all federal employees.

THERE ARE AROUND 15,000 INDEPENDENCE DAY FIREWORKS CELEBRATIONS EVERY YEAR. According to the American Pyrotechnics Association, around 15,000 fireworks displays will take place for the Fourth of July holiday (even if some aren't exactly on July 4). Though pricing varies, most small towns spend anywhere from \$8000-\$15,000 for a fireworks display, with larger cities going into the millions, like the Boston Pops Fireworks Spectacular that averages more than \$2 million. Unfortunately we'll have to wait until 2021 to see those spectacular fireworks!

WE'LL EAT AN OBSCENE AMOUNT OF HOT DOGS. Around 150 million, to be more specific—that's how many hot dogs will be consumed by Americans on the Fourth of July. According to the National Hot Dog and Sausage Council, that amount of dogs can stretch from Washington D.C. to Los Angeles more than five times.

THREE PRESIDENTS HAVE DIED, AND ONE WAS BORN, ON THE FOURTH OF JULY. You probably know that both Thomas Jefferson and John Adams died on July 4, 1826—50 years to the day after the Declaration of Independence was adopted. They're not the only presidents to have died on the Fourth, though; James Monroe—the nation's fifth president—died just a few years later on July 4, 1831. There was one future leader born on Independence Day. The country's 30th Commander-in-Chief, Calvin Coolidge, was born on July 4, 1872.

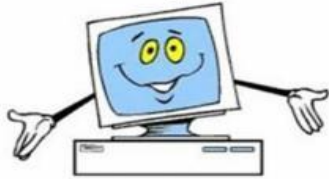
