

STEP 1 RATES**APPLICABILITY**

Applicable within the entire territory served.

AVAILABILITY

Available for general domestic, commercial and industrial service.

(I) RATES (Customers with metered water supply)

First	2,000 gallons used per month	\$18.49 per 1,000 gallons
Next	3,000 gallons used per month	\$17.92 per 1,000 gallons
Next	5,000 gallons used per month	\$16.39 per 1,000 gallons
Next	10,000 gallons used per month	\$14.10 per 1,000 gallons
All Over	20,000 gallons used per month	\$13.21 per 1,000 gallons

(I) MINIMUM CHARGE

No bill will be rendered for less than the following, according to the size of the meter installed:

5/8	inch meter	\$ 36.36 per month
1	inch meter	\$ 90.90 per month
1- 1/4	inch meter	\$ 132.71 per month
1- 1/2	inch meter	\$ 181.80 per month
2	inch meter	\$ 290.88 per month
3	inch meter	\$ 581.76 per month

6	inch meter	\$1,818.00 per month

RETURNED CHECK CHARGE

A service charge equal to the actual bank fee assessed to the District, not to exceed \$25.00, will be imposed upon any customer whose check for payment of charges is returned by their bank due to insufficient funds.

To be charged whenever the supply of water is turned off for violations of rules, nonpayment of bills or fraudulent use of water.

TAP FEE

The following charge is to be made whenever the utility installs a new tap to serve an applicant.

A tap fee of \$350.00 will be charged to all customers who apply for service outside of a certificate proceeding before the Commission for each new tap to the system.

DELAYED PAYMENT PENALTY

The above schedule is net. On all accounts not paid in full when due, ten percent (10%) will be added to the net current amount unpaid. This delayed payment penalty is not interest and is to be collected only once for each bill where it is appropriate.

(I) **LEAK ADJUSTMENT INCREMENT**

\$5.67 per 1,000 gallons is to be used when a bill reflects unusual consumption which can be attributed to eligible leakage on the customer's side of the meter. This rate shall be applied to all such consumption above the customer's historical average usage.


