# WHAT IS THE PLAN FOR LOS ANGELES ECONOMIC RECOVERY?

Our speaker at the Wednesday evening, February 17 Zoom Meeting will be Los Angeles City Councilman Paul Krekorian. He started his career as an attorney and has spent close to two decades in public service. Councilman Krekorian was a member of the Burbank School Board, served on the California State Assembly and was elected as City Coun-

cilmember in 2009. He grew up in Southern California, graduated from USC and obtained his JD from the UC, Berkeley School of Law. He has a passion for protecting our environment and public safety.

Councilman Krekorian's District includes Studio City, North Hollywood, Van Nuys and adjacent areas. He serves as Chair of the Budget and Finance Committee of the Los Angeles City Council. He, therefore, is in charge of working out solutions for the City's \$675,00,000 deficit for the fiscal year ending June 30, 2021. Councilman Krekorian also serves as a Member of Los Angeles County Metropolitan Transportation Authority ("Metro). Metro will decide whether an above ground train system will be built along Sepulveda Boulevard in Sherman Oaks.

### WHAT YOU NEED TO KNOW ABOUT DANGEROUS SB 9


Senate Bill 9 (SB 9) is the new version of SB 1120 which was introduced in the last California legislative session. It was defeated only by a last-minute timing technicality. Toni Atkins, the President Pro Tempore of the California State Senate, wrote SB 9. Because of her powerful position, most senators will not oppose this bill even though it is unnecessary and destructive.

#### The bill has two provisions:


- Provision 1: would allow you to add another separate house (no size restriction) on your lot. This does not restrict you from also adding, already allowed, auxiliary unit (ADU) 1,200 sq. ft. and a jr. auxiliary unit (500 sq. ft.). 4 separate units where one house stood.
- Provision 2: would allow you to split your lot (gated and hillside communities not exempt) equally in half, each half no smaller than 1,200 sq. ft. Each split lot would be allowed to have two houses plus two additional housing units – for a total of four housing units per split lot. Eight units where one house stood. A neighborhood that today has 400 homes could become a neighborhood of 3,200 housing units as a result of this bill.


#### The bill also:

- Requires NO infrastructure improvements. All of this new housing will depend on current water, sewer, and power infrastructure and also current police, fire and school budgets.
- Requires only 4-foot side and rear setbacks. Currently, zoning requires 5-foot side yard setbacks and 15-foot rear back setbacks to meet life/safety issues.
- Poses a huge risk in high-fire areas by densifying properties and shrinking the space between homes.



Currently Allowed





- Reduces our permeable surface with more house and less open land, impacting aquifers and reducing the urban canopy. Many backyards and trees will be removed for housing.
- Eliminates our hard fought Mansionization Ordinances and allows the return of McMansions.
- Fails to mandate our number one problem affordable housing.
- Encourages land speculation that will cause investment companies to buy up properties made more valuable by allowing more housing per lot.

This bill is a developers' dream and a concern to all of us. One house for sale can potentially yield 8 houses.

We don't need this bill. Single-family neighborhoods already allow 1,200-square-foot accessory dwelling units (ADUs or granny flats) and a 500-square-foot Junior ADUs on their existing property. This alone could yield significant amounts of affordable housing without further opening up our neighborhoods.

SOHA opposes SB 9 and hopes Senator Bob Hertzberg, Assemblyman Adrin Nazarian, and Councilwoman Nithya Raman will call out this bill for what it is – another attempt at destroying single-family neighborhoods without solving the real affordable housing problem.

### **GET TO KNOW YOUR S.L.O.**

LAPD Van Nuys Division has seven Senior Lead Officers (SLOs) that cover each basic area of the Division. Sherman Oaks has three SLOs assigned to the areas shown on the map below.


SLOs act as the focal point for LAPD's Community-Based Policing efforts. They coordinate with other LAPD officers assigned to the area and establish effective and lasting communication with members of the community.

SLOs implement problem-solving strategies to address quality-of-life issues within their communities and work closely with the Sherman Oaks Neighborhood Prosecutor, Andy Soliman.

They establish Neighborhood Watch groups, routinely patrol their community areas, and coach and train officers on Community-Based Policing philosophy.

SLOs typically work four 10-hour shifts per week and are not deployed on week-ends.

# WILL THE "SLUSH FUND" TASK FORCE CONTINUE TO HELP MAINTAIN TRANSPARENCY AND ACCOUNTABILITY?

Every year, each of LA's fifteen City Council Members receive \$1.0 to \$1.5 million from the city to use at their discretion. The official name for these is Discretionary Funds, but the press has often dubbed them "slush funds." It's very hard, often impossible, to determine how they are spent. Many people complained about a lack of transparency for these funds, and our former Councilman David Ryu made a campaign pledge for full transparency. On July 1, 2015, he created the Discretionary Funds Task Force, a group of nine residents from across Council District 4. Both SOHA and the Sherman Oaks Neighborhood Council had a member on the original Task Force.

The Discretionary Funds Task Force gave Council District 4 constituents the transparency and accountability they had asked for by:

- Reviewing and advising on the use of discretionary funds expenditures;
- Crafting policies and guidelines to distinguish appropriate uses of funds;
- Soliciting community input and providing recommendations for specific long-term discretionary funds projects;
- Reviewing and recommending approval or disapproval of previously rescinded discretionary funds; and
- Advising the Council Office on discretionary funding matters as requested.

But Council District 4 and the Task Force went even farther. Anyone could go to the Council District 4 website and get a list of every Discretionary Funds dollar that was spent – when, how much, to whom, and for what. It didn't matter if it was \$150 to help get chairs for a neighborhood block party, a thousand dollars for a youth program, or several thousand dollars to defer costs for a new traffic island to prevent accidents in Council District 4.

We hope our new Councilwoman Nithya Raman will continue the Discretionary Funds Task Force and the great work that it has done. We deserve this transparency to ensure that the council office spends our funds wisely and equitably, and the public is able to see how tax money is being spent.
