Mayor Davenport expressed the need to get a new A/C mini split for the board room at Aaron Park. The lowest quote came in at \$2950 from Charles Fix it all.

A motion to approve the expenditure for the A/C unit at Aaron Park from the Parks and Rec budget was made by Councilor Stepney and seconded by Pro-Tem Reed (4 yea). Motion passes.

Mayor Davenport invited citizens and The Council to attend Thursday the 19th at 11:00 a.m. the Elmore County Press Day hosted by Mid-South RC&D. It is an opportunity to meet with Mid-South and Legislature that was responsible for granting us with grant funds for Panther Palace cameras and the Middle School. He encourages all to attend.

A motion to table the PD request was made by Councilor Stearns and seconded by Councilor Stepney. (4 yea). Motion passes.

Mayor's Comments:

A motion to approve Resolution 224-10-001 to allow Legislature to handle all partial property annexation was made by Councilor Stepney and seconded by Pro-Tem Reed. (4 yea). Motion passes.

Mayor stated that Britt Green from First Baptist will take back over the Trick or Trunk festivities on October 31, 2024. The council allowed the road to be closed from Main Street to First Avenue.

Mayor also told The Council that the water works were non-compliant with reporting a quarterly DBP report to ADEM. The consequence will be a fine and informing all citizens to the tune of between \$3-\$5,000. Mayor Davenport is meeting with rural water this week to learn more.
