#### "Humbly asked Him to remove our shortcomings"

He said: I want to live sober today. Sometimes I find that I am still afraid of

being healed. But I don't know why so it must be a character defect. Who would want to stay ill?

Three years ago, a friend of mine who is now coming up on 30 years sober told me that she was going to work on some of her strong personality points. She is known for her uncompromising personality in the rooms where I encountered sobriety. I was blown away by her statement, you mean, you still use the steps when you are almost 30 years sober? Yes, she said, because she didn't want to be one of those people in AA with long term sobriety who are totally insane and proud of it. So she entered into the steps again with her sponsor.

I don't get to hurt other people or judge other people and then blame it on my personality just because I was blessed today with sobriety. To be sober, in the AA sense, is to grow as a human spiritually. When I see my character defects I use inventory, prayer and meditation so that I don't act that way in the future.

In my relationship with my higher power, I am equally responsible for my prayers coming to life.

My character defects, in all their glory, are not going to go anywhere as long as I keep up the actions associated with them.

When I stop actions that I know hurt other people, then God removes my character defect. When I stop reacting and acting on impulse, then God removes my character defect. When I stop lying, cheating and stealing, then God removes my character defect. That is what I share about in the meetings, how my prayers come to life by working the steps. Meetings are a space of surrender.

**Let go** (of my character defects) **and let God** (heal me). And, now that I am sober a few days, the relationship I can love is the one I have with my higher power.

She said: In Step Seven I embrace relationship. I begin to regard the people and the world around me in a new light. I learn to

**Albert Einstein once** said, "There are only two ways to live your life. One is as though nothing is a miracle. The other is as though everything is a miracle. I prefer the latter." How did man build ships that float, airplanes that fly, and rockets that bolt to the moon? Cause and effect in the natural world were observed, embraced and directed. When we connect with our higher power we become conductors of that natural power. My only goal becomes connecting to the source and removing any obstacles that muddy that connection. Miracles occur when we connect with our higher power.

What interferes with my connection to this higher power that resides within me? Most of my life I related with the world around me to get results. Before I got sober, I viewed the moments of my life as either obstacles to overcome (with happiness at the end) or something to resist. Understandably I was impatient for results when I was suffering through the process. In sobriety, I've learned that life is process.

If I can't enjoy the process of my life, how can I expect any result to be fulfilling? For it is there, in the moments of our lives, where our higher power exists. Connection occurs in this moment. The beauty and the miracle of my life lies in the relationship I have with my moments.

Connection with my higher power allows me to celebrate the beauty all around me, and to integrate that beauty into my life. It allows the beauty I see to touch me, and to change me. Connection alters my thinking, and the mere recognition of it continues to work from the inside out. It influences how I relate

#### **June in Our History:**

**June, 1935:** "The Upper Room" is first published coming out once a month with meditation for each day. It was required reading for early A.A. members before our Big Book was written.

**June 10, 1935:** Dr. Bob, who becomes AA's cofounder, takes his last drink on this date. June 10<sup>th</sup> is considered by most A.A. members and historians as the birth date of A.A.

**June 1938: Bill W. and Hank P.** begin slowly putting down on paper what will become our Big Book.

**June 1940:** Six inmates in San Quentin read a copy of the Big Book together and form the first A.A. group inside a prison. Bill W. was their guest speaker several times.

**June 30th, 1941: "The Serenity Prayer"** is found in the NY Herald Tribune newspaper by two members and brought into our New York office. Bill W. liked it so much it was reprinted and sent out with all replies to inquiries about A.A. from that day forward.

**June 1945: 2500 A.A.** members attended the 10<sup>th</sup> Anniversary of A.A. in Cleveland, reports the Cleveland Press. As of 1945 Cleveland has 14 of 500 A.A. groups in North America.

**June 1947:** This issue of the Grapevine carried for the first time, the A.A. Preamble, written by the Grapevine's editor Tom Y.

**June 1981:** Switzerland holds its 25th A.A. Anniversary! Lois (Bill's widow) was one of the guest speakers.
