02/10/2021 – Boire Properties LLC/Infinity Aviation Services LLC – Request transfer of Land Leases and Operating Rights

Mr. Greg Lison discussed the restructure of Infinity Boire Properties LLC. He is requesting the board approve the transfer of land leases E1503, E1506, E1507 from Boire Properties LLC to Perimeter Road Properties LLC. He is also requesting the Operating Rights Agreements be transferred from Boire Properties LLC and Infinity Aviation Services LLC to Infinity Aviation Group LLC.

REPORTS

TOWER REPORT

Chairman Woods reported for the month of January 2021 the traffic count was 6,080 operations which is down 421 (-6%) operations from December 2020 and down 795 (-12%) operations versus January 2020.

AIRPORT MANAGER'S REPORT

Airport Manager Chris Lynch reported on the following topics.

Upcoming events

• June 23rd – June 27th – Commemorative Air Force at ASH. The CAF B29/B24 Squadron aircraft attending this event will be: B-29 Superfortress FIFI, B-24 Liberator Diamond Lil, Wasp T-6 Texan, P-51 Gunfighter and PT-13 Stearman.

Other items of interest

- The FAA is considering a request by the USAF to establish the Chugs Temporary MOA (T-MOA) in the vicinity of Windham, VT. The purpose of this T-MOA is to support the upcoming Exercises Eagle Claw 21-01. Eagle Claw 21-01 will take place from 1 to 30 June 2021.
- Currently, the NAA does not have any potential tenants on our waiting list for aeronautical use of airport hangars. There are two (2) T-Hangar for sale located at 13 Perimeter Rd. Also, community hangar rental is available from Nashua Jet Aviation and Infinity Aviation.
- Sarah Marchant, City of Nashua Community Development Division Director has asked that we share information about "Imagine Nashua" Citywide Plan For Nashua.
- On February 12th, we received notification from the NHDOT that the Nashua Airport will be receiving funds from the FAA for the Airport Coronavirus Response Grant Program (ACRGP) to help reimburse our airport for operations, maintenance, and debt service expenses.

AIRPORT ENGINEER'S REPORT

Nik Ippolito appeared on behalf of the airport's engineering consultant, Gale Associates, Inc.

CONSTRUCT ONLY – Pavement Maintenance Phase II (NHDOT No TBD)

This Project is to reconstruct taxilanes between hangars located on the north-west side of the Airfield (Runway 14 end.)

Project Status:

- At this time, the grant offer from NHDOT/BA has been received, fully executed, and returned to NHDOT.
- The Contracts between the NAA and Continental Paving have been fully executed. Gale is in coordination with Continental Paving to develop a project schedule as well as begin preparations for construction. By next month's meeting we should have an anticipated start date, this will allow the NAA to notify airport users of the upcoming work.
- Continental Paving is asking if there are any provisions for modified unit prices since the bid. This question has been escalated to the NHDOT/BOA.
- Once a commencement date has been agreed upon, Gale will prepare the Notice to Proceed for this date and begin coordinating a time/place to conduct the mandatory pre-construction conference.

REHABILITATE TAXIWAY 'A' AND ASSOCIATED TAXIWAYS

This Project is for the design and construction phases necessary to rehabilitate Taxiway 'A', install new taxiway edge lighting (MITLs), and to address the grading issues at the intersection of Taxiway 'A' and Taxiway 'D'.

Project Status:

- Gale's design effort is nearing completion. We anticipate having the 95% design documents completed by Friday, February 19, 2021. This 95% design will be distributed to the NAA, NHDOT/BA and FAA for review and comment.
- Once comments are received on the 95% documents, Gale will make the necessary changes and address all comments in letter form.
- Following final revisions, Gale will work with the NAA to advertise and distribute bid documents to qualified bidders.
- Gale's Contract for this project has been sent to the Authority for comparison to the
 Independent Fee Estimate; based on discussions with Mr. Chris Lynch, it appears that Gale's fee
 is within 10% of the IFE provider's fee even with the addition of a permitting coordination phase
 with the Natural Heritage Bureau. For this reason, we believe that the Airport may vote on
 Gale's Contract tonight.
