# Black Bear Festival 2019

## Rules and Regulations

### **Attention Food Vendors:**

**Hand Washing stations will be required at each food booth.**

**Food trailers are required to have their state issued permit and scorecard on display.**

**A copy of your health inspection card must be provided with the vendor application.**

**Churches, schools and non-civic groups are not required to have a permit.**

**Contact Environmental Health with questions regarding permits. 706-517-1400**

1. Show space will be available to businesses/companies/organizations (local, state, and federal). Booths are to be reserved in your name only, no shared booth applications will be accepted. To ensure high quality of exhibits, the festival committee reserves the right to ask exhibitors to remove any items they determine unsuitable from displays. Food vendors may be limited.
2. Children will be “trick or treating” Saturday evening from 5pm to 6pm. It is not mandatory, but we would like for all our vendors to provide treats for the children. If you choose to provide treats for the trick or treating event, please display a sign at your site, so children can visit your area.
3. Set-up begins Friday, October 18, 2019 from 1pm-6pm, Saturday, October 19, 2019 from 6:30am to 9am, & Sunday, October 20, 2019 from 6:30am to 9am. All exhibitors are expected to set up before festival hours (10am-6pm on Saturday, October 19, 2019 & 10am-5pm on Sunday, October 20, 2019.) and remain open until closing time. **The BBF is a two-day festival all exhibitors are expected to stay both days.** No vehicles will be allowed in the exhibit areas between 9am-7pm on Sat. & 9am-6pm on Sun, **NO EXCEPTIONS.**
4. **All exhibitors must bring tent, tables, 12-gauge 100 ft extension cord for access to power (must indicate on previous page), etc. for set-up.** The space provided may or may not be on pavement. The festival is providing space and limited power. Access to power must be requested on the festival application. No coffee makers allowed, unless you provide your own power. **Vendors may furnish electricity to their booth with a generator.**
5. Sales tax collection and payment to the State of Georgia is the exhibitor’s responsibility.
6. All exhibitors are responsible for the clean-up of their space. Let’s Keep Murray Beautiful!
7. I give permission to the Black Bear Festival and the Chatsworth-Eton-Murray County Chamber of Commerce to use photography or videography of me, as well as, my booth and all items made or displayed during the Black Bear Festival. Photography or videography may be used in print materials, on the Black Bear Festival website, and the Chatsworth-Eton Murray County Chamber of Commerce website, press release, or other social media sites.
8. **No booths will be allowed to breakdown prior to the close of business at 5:00pm on Sunday. Violators will not be allowed to participate in future Black Bear Festivals.**
