August 2018 Legislation Report CALIFORNIA

The Senate and Assembly reconvene after summer recess on August 6. You decide! AB 84 Political Reform Act of 1974: political party committee disclosures by Democrat Assemblyman Kevin Mullin (D) co-authors Speaker Rendon (D) and Republican Leader Brian Dahle. Under the changes, Assembly and Senate Caucuses—both Democrat and Republican—can set themselves up as political action committees (PACs) and take in large sums of money from donors. It also allows the Caucuses to endorse in primaries and donate money to their favorite candidates. This will formalize what is already being done, legally, in other manners. If passed, it changes the relationship of the Caucuses to the State Parties.. This would make the objectives of the political parties clearer. The Parties will be doing voter registration, social media outreach, expansion of coalitions, the grassroots of campaigns —instead of looking like they are chiefly responsible for fund raising for candidates. This bill is also in Committee and likely to pass. Source: Steve Frank's Capitolpoliticalreview.com

OPPOSE AB 931, Criminal procedure: use of force by peace officers. The intent of this bill is to raise the use-of-force standard for engagement above what the courts have established as when an officer reasonably perceives a threat to life. A higher standard means officers would have to delay, second-guess their decision, wait to pursue, or otherwise employ a checklist during rapidly advancing and extraordinarily dangerous situations. This only complicates the already complex split-second decisions required by officers in a deadly force situation.

This is in the Senate Appropriations Committee and is close to passage. Source: leginfo.legislature.ca.gov.

OPPOSE AB 2943 (update) Unlawful business practices: sexual orientation change efforts. This bill makes it a fraud to offer help, information, or materials to adults questioning their gender or sexuality. This bill has passed the Senate and is now in the Assembly, close to passage. WASHINGTON D.C. SUPPORT THE “GOODLATTE BILL” on immigration. It may be back! In exchange for granting temporary legal status to immigrants who were brought to the United States as minors, the Good latte bill would authorize construction of a wall along the U.S.-Mexico border. It would also . . . end a green card program allowing family members to come to the United States (so-called “chain migration”) reduce the number of documented immigrants by about 25 percent (from over 1 million people a year to roughly 800,000 make the “E-Verify” program mandatory so that employers can hire only legal workers and, among many other items increase the number of Border Patrol agents. SUPREME COURT The Janus Decision – Good news! The Supreme Court has ruled in Janus vs. AFSCME case. The court sided with Janus in a 5-4 decision, barring public sector unions from demanding “fair-share” fees from non-union members and freeing union members from paying mandatory dues. This is a huge win for conservatives, but it will have even more significance in our state of California. Public unions . . . outspend even corporations in legislative races. Now unions in California will have to prove their worth to members, instead of getting politically involved in issues that have nothing to do with union representation. The California public employee unions have been bracing for this decision and have worked with the legislature to pass laws bolstering their power this past session. Some of these laws include guaranteeing public unions access to new employees and requiring public agencies to follow union rules even if employees refuse to pay union dues. Some unions anticipate losing one-third to potentially half of their membership, which would severely weaken their positions . . . Source: CFRW's Capitol Update, June 28, 2018 Court Nominee Brett Kavanaugh – More good news! Support his candidacy when Senate confirmation hearings begin.

Contact Senators Feinstein (Feinstein.senate.gov) and Harris (Harris.senate.gov) in support of Kavanaugh. (Yes, we know how they'll vote, but at some point there will be a “tipping” point. The more who weigh in, the sooner it'll arrive—even in California. Sign this petition . . . Don Rosenberg lost his son in a car accident caused by an illegal alien in 2010. Rosenberg is leading a movement to save lives on the highways and the quality of life in California. Rosenberg's proposal, called the Children, Family, and Community Protection Act would require cooperation between state and local enforcement in efforts to verify the immigration status of anyone who is arrested and suspected of being in the U.S. illegally. The Children Family Act will also: Repeal California's Sanctuary State laws Repeal the law that give illegal aliens the right to get driver's licenses Prohibit automatic voter registration in the state, something Rosenberg thinks can help prevent voter fraud. It would also prohibit local governments and police agencies from limiting cooperation with ICE and other federal authorities — something currently prevented in certain cases by California's recently enacted Senate Bill 54, better known as the “Sanctuary State” law.
