## Just a thought...

*Victim Advocacy in*

*Law Enforcement*

Being a victim of crime is a traumatic event in someone's life, one that most people are not prepared for. In addition to the pain inflicted upon them by the criminal, they may also experience confusion, frustration, and even heartache having to relive the experience while going through the criminal justice system. Since law enforcement officers are often a victim's first contact with the system, it is imperative for officers to have an understanding on the dynamics of trauma, as well as victims rights, in order to better serve victims and/or survivors of crime.

**The Harford County Sheriff's Office Victim Services Unit**

The Victim Services Unit of the Harford County Sheriff's Office was created to provide

necessary services and actively assist victims of violent crime. This is accomplished by:

- \* providing support and encouragement to victims and/or survivors at the scene of the crime through crisis intervention 24/7, helping them to understand the law enforcement process, whereby allowing the detectives to investigate the crime;
- \* to provide victims and survivors information on what resources may be available to them;
- \* to guide victims and survivors through the criminal justice system;
- \* to ensure that victims are informed of their lawful rights, and that victims who choose, shall have the ability to exercise those rights;
- \* to facilitate healing and resolution for victims and survivors through referred support group services and pro bono counseling services.

**Law Enforcement Training and the Benefits to Victims**

A large part of the responsibilities of the Victim Services Unit is to provide the necessary training to law enforcement recruits and 911 operators during their initial academy training, as well as to senior law enforcement officers during their in-service training on victim

issues. This is extremely important as law enforcement officers are primarily the first on the scene, when victims and survivors are generally in traumatic shock. One particularly important skill law enforcement officers be trained on is the proper techniques in delivering a death notification, as they are usually the people making these notifications. The Victim Services Unit does assist the responding officers, but as this is a one person unit, there are many more times the officers have to go it alone and there is only one opportunity to get it right.



**Community Service**

Community service is also a critical component of a law enforcement victim services unit.

Helping the community to understand that victims have specific rights and services available to them before a crime occurs helps them to know where to turn in the event they are ever struck with tragic circumstances. Additionally, providing knowledge and resources in advance can also possibly help to prevent the victimization of some.

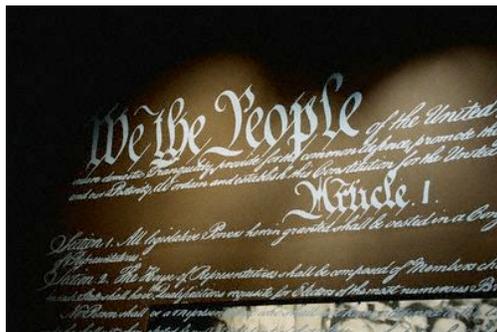

## News From the Field

The Maryland Crime Victim Resource Center was recently awarded a \$500,000 grant from the Department of Justice to assist victims of identity theft and fraud. The Center plans to use the money to provide direct assistance to victims, work with law enforcement agencies to help victims and investigate their cases, and encourage pro bono work by attorneys. The grant was announced by U.S. Attorney Rod J. Rosenstein, who said MCVRC will work with the Maryland Identity Theft Working Group, which coordinates and promotes the investigation and prosecution of identity theft cases in the state, as well as other groups.

## Hot Topics

With an increase in international terrorist acts, the likelihood of a U.S. citizen becoming a victim has become greater, and so have the chances that those victims or their families will be contacting victim service providers in the U.S. for assistance. With that in mind, did you know that there is a compensation program that provides financial reimbursement to victims of international terrorism?

The International Terrorism and Victim Expense Reimbursement Program (ITVERP) was authorized by Congress to reimburse eligible victims of international terrorism that occur outside the United States. This program, administered through the U.S. Department of Justice, Office for Victims of Crime (OVC), was implemented to assist U.S. nationals, U.S. government officers, and employees of the U.S. government (including foreign nationals working for the U.S. government) who become direct victims of international terrorism abroad and who have suffered direct physical or emotional injury or death as a result. Similar to most state victim compensation programs, ITVERP reimburses eligible victims for medical, mental health, and funeral and burial expenses that were incurred as a direct result of a terrorist act. In addition, ITVERP also will reimburse eligible victims for property loss, repair and replacement costs, as well as temporary lodging, transportation, telephone costs, and emergency travel. Costs not covered under this program include: attorneys' fees and legal expenses, lost wages, pain and suffering, and loss of enjoyment of life or loss of consortium.

The criteria for eligibility is that the victim must be a U.S. national, U.S. government officer, or U.S. government employee; have suffered a direct physical or emotional injury as a result of an act of international terrorism; and the act must have occurred on or after December 21, 1998 for which an investigation or prosecution was ongoing or began after April 21, 1996. The filing deadline is 3 years from the effective date of the program, which was October 6, 2006.
