128 Law Day Presentations Reach Nearly 6,000 Students!

Many Louisiana cities have local bar associations and other organizations that conduct wonderful programs in honor of Law Day. The Louisiana Center for Law and Civic Education (LCLCE) sought to reach those students who were not fortunate to be a part of one of those programs.
