

The last GSSN meeting of 2008 was held December 3, 2008 at The American Legion Hall, Henderson NV. There were 47 attendees; 2 new members and 5 visitors. GSSN Highgrader Newsletter Archive "Placer Gold"

Placer gold occurs in cemented and un-cemented gravels of Tertiary and Quaternary age. Gold is sparsely spread throughout the gravels and in concentrated here and there, in buried channels. The older gravels have been neither worked nor adequately tested. Productive gravels found to date are weakly-cemented remnants of alluvial fans of Quaternary age, which underlie most of Gold Basin, Hualapai Valley and the Grand Wash Cliffs. The richest pay-dirt is at the base of the weakly cemented gravels. Placer gold is often ragged and is sometimes attached to fragments of quarts or schist, indicating that the original source is not far away. Abundant black sand accompanies most of the gold and prospectors should be on the lookout for platinum group metals and rare earth minerals as they have been reported to occur in the region. The Most productive areas have been in Arroyos where the weakly-cemented alluvial fan gravels have been reworked and the gold has been concentrated by running water. There are also buried channels within the alluvial fan gravels. In arroyos, pay-dirt is often within just two to three feet of the surface. Testing by means of dry washers has indicated an average of .02 ounces of gold per cubic yard under much of Gold Basin, Hualapai Valley and Grapevine Mesa.

The vote to correct the Nov. 5th meeting's minutes was unanimous. Nick then went on to new business and recommended that an Audit Committee be formed and asked for three volunteers. Jake Jakl was Nominated by John Sears and he accepted the position. Sam Ponziani was Nominated but declined. John Gee was Nominated by Dolores Gee and he also accepted. 

Several of the members shared stories of their experiences recalling old and not so old ad-


ventures. The membership person was kept busy greeting the members and guest at the shade shelter. Several pieces of equipment were on display for any visitor or new member to inspect.

treasurer's report, and Marcia Richwine, the new head of membership gave the membership committee report. Nick then commented on the smooth transition of the Presidency from Bob Shiroky to Himself, and asked the previous year's officers to come forward at which time he presented certificates to each of the former GSSN officers, acknowledging and thanking them for their efforts. He mentioned that Bob Shiroky remained a director of GSSN. Next the three person Audit Committee received letters from Nick J. relative to their being on standby status until instructed to convene a meeting to review the GSSN books. Nick then asked for a volunteer to do the GSSN Newsletter, and Janet Schelling agreed to do so on a trial basis. Nick then asked for a volunteer to act as club librarian. At this point a discussion ensued about listing the contents of the library in the GSSN Newsletter, and having a list of all library items available at each monthly meeting for members' perusal. Following prescribed rules, a member could contact the librarian to request material(s) which could be picked up at the next meeting and checked out for a certain time (ie., 30 days). If the material(s) were not returned on time, a late fee of \$1 per month would be assessed. The discussion also included handling of library materials and limiting the number of items which could be checked out by members, as well as deciding how to loan club equipment in addition to books and printed materials. Subsequently, Fred Zajac made a motion to impose a late fee of \$1 per month per item. Dennis Johnson seconded the motion. Nick asked for a vote-which was approved unanimously. Nick then mentioned the Fort Mohave Gold Show coming up January 25th and the Primm Gold Show scheduled for April 25th-26th, 2009. After an extensive discussion of the pros and cons of the GSSN having a 50-50 Drawing at meetings, Fred Zajac made a motion to table this agenda item until the February 4th, 2009 meeting. Melissa Nichols seconded the motion. Nick called for a vote, which was unanimously in approving the motion. Nick then asked for a 20 minute break at 7:50pm. The meeting resumed at 8:10pm. The drawing /raffle was held. Bob Shiroky won the \$5 door prize, and 12 other items (as noted below) were raffled off. Nick then asked about having a club outing on January 17th, 2009. after comments by various members about wetness and other considerations, Fred Zajac made a motion to schedule the Jan. 17th, 2009 outing, which was seconded by Morris Seguin. The subsequent vote unanimously approved such motion. Morris Seguin then announced that lunch would be available at 11:30am (NV time) at the fire pit. Nick then announced that at the January 3rd, 2009 board meeting, it was decided that dues would be \$45 for New Members and \$30 for Renewals (which higher rates had previously been in affect). The meeting was then adjourned at 8:35pm.
