Unfinished Business:

Emergency revetment projects at Lakeview and Hutchinson: President Benson thanked the previous Town Council for setting it up to be able to do the work. He thanked Ed Bracken for being a hero to the Town and volunteering his time and expertise. He thanked Matrona Malik and her group of volunteers. He stated that the work at Hutchinson held up and without it, the storm on Saturday could have been devastating. Lake View also took a beating, but it could have been worse if not for what had been done. Benson met with the National Park Service (NPS) and a representative from Trap Bags to determine what to do: Trap Bags is going to donate more bags, NPS will supply the labor, Ed Bracken will oversee, and the Town may provide additional sand. The tentative schedule would have them begin next Monday. Benson also read a letter from the Indiana Department of Homeland Security which stated that there are no funds available at this time and what is happening does not meet their definition of emergency.

Councilor Blackburn motioned that Town Council approve a change order with City Sands, LLC, in an additional dollar amount not to exceed \$5,440.00 for up to 1,814 more cubic yards of sand. Blackburn also stated that a declaration of emergency is still in effect. Councilor Malik seconded. Discussion included description of new configuration with 2 rows of bags on bottom and a third row on top of the two. Unanimously approved.

Councilor Blackburn thanked President Benson for his leadership on this emergency project. He further thanked the previous Council for their work on this.

Vice President Loeb asked if the Town's sand should be tested. President Benson stated it was not cost effective at \$10,000 for testing.

President Benson suggested that the Town start exploring alternative plans for accessing Lake Front homes.

Radmilla Bogdanich (106 S. Montana) asked if there were long term plans. Benson answered that the NPS had done a study years ago but could never get the funding for it. Blackburn stated that the Plan Commission should be looking at that as they update the Comprehensive Plan. Weber suggested revisiting the studies and collaborating with the NPS.

Marshal Clapp warned everyone to stay off the stairs at Shore and that he has closed them. He additionally warned people to use caution at Rebora.

Toots Foy (424 E. Myrtle) inquired about fund-raising. Malik suggested reaching out to the ABSR Foundation when and if it's needed.

Sam Olin (431 E. Roberts) asked if there was an emergency plan if the road was breached. Benson said that the utility companies have plans.

Annette Young (307 E. Brightwater) asked if the Town had talked to US DOT. Benson said it was not interested in helping.

Coastal (Historic Landmark) Grant: No update.

A/V equipment: CT Hundt reported she is still working on finding a vendor to work within State laws. Councilor Weber motioned to approve spending up to \$5,000 from the LIT fund for A/V equipment. Councilor Malik seconded. Unanimously approved.

New zoning map: Nothing new to report.

Census 2020: Benson reminded everyone this was happening this year and to make sure everyone is counted.





President Benson has met with Senators, Representatives, and other parties regarding the need for short term, mid-range, and long-range plans for erosion issues.





To Consider a bond for the Town

Marshal Clapp presented updates for the Street Department. He encouraged people to stay off the closed beaches and especially Hutchinson. NIPSCO has begun process of checking all the gas valves under the roadway.

Request for replacement police car lease

Marshal Clapp requested permission to purchase a new Police F150 for \$32,198 before 2021 due to the increasing repair and maintenance costs of the 2013 vehicle.

Councilor Malik motioned to approve Councilor Weber seconded. Unanimously approved. Additionally, it was requested to use \$5,000 from the LIT Fund to pay off one of the leases earlier in order to maintain just 2 leases in 2021.

Councilor Malik motioned to approve Councilor Weber seconded. Unanimously approved.

Erosion Expenses and Estimates

President Benson explained his spreadsheet on what was needed to prepare report for the governor utilizing the costs of projected erosion damage. Councilor Weber to write narrative to accompany proposed numbers.

Permission and spending plan for draft next steps

President Benson presented numbers for what can be done immediately for the Lake Shore Erosion Project. There was discussion on different revenue sources; erosion donations and utilizing some cash flow from the Town. The money on hand is enough to start getting supplies now. Firstly, there is free sand available from private property with the Town paying for equipment and Ed Bracken providing free labor. The sand needs to be tested (approximately \$2,000) to the National Park's guidelines. President Benson has reached out to Microbac to do testing. Blasting for rock begins the first week of April and the Town will have access to large rocks at that time.

Councilor Blackburn motioned to move forward with testing and acquiring the sand, spending up to \$22,000 from the CCD Fund. Councilor Weber seconded. Unanimously approved.

Councilor Weber reported that the National Park does not have funds to contribute to fencing. Weber further reported that CARDNO has put up fencing and they are done with planting until spring.




