- Memberships for children under 18 include a required membership for one non-skating parent or guardian. The non-skating parent does not receive a free t-shirt, but may order one for a fee if desired. If both parent and child wish to test/compete, they should register as an adult skating membership and an additional family member skating membership.
  
- BSFC Voting privileges if 18 years or over. BOD eligibility is 18 years or older.
  
- **Club T-shirt for those who join by June 30, 2018.** The exact number of T-shirts are ordered and are not available after that date. T-shirts are distributed at the annual club pool party and may also be picked up at the rink after that date. See the membership category to see if one t-shirt is included. Additional t-shirts may be ordered for \$10 if included with the membership application and received by June 30.
